What's Been Happening?

As President Patty Huff says in her letter (attached) we've been busy working on saving the old Bank of Everglades Building. One highlight was that our Golf Gala in March was a great success (see photo above) with thanks to Lisa Resch of Carolina Catering Company (C3kitchens.com) who provideed the food & services for the event pro-bono.

Another accomplishment is that we have reached out to various sources of funding (local, state, federal, and private) for grants.

One of our most recent endeavors was soil testing at the property in preparation for structural work on the foundation. As the engineers bored down, they found everything from sand to limestone to compressible peat. The results are being discussed by our structural engineers and architect.

What's Being Planned?

We're already looking forward to the 2022-2023 winter season and can announce that our signature event will be a Homes & Gardens Tour when owners open their lovingly-restored historic houses to ticket-holders.

We held the first one in 2010 which was very successful and we've been asked since the last one in 2014 when we were going to do it again. The date we selected in 2023 is Saturday, March 11, and we've already entered it on the United Arts Council calendar.

Before that, in early November, we plan to hold another Music Festival on the lawn of the historic Rod & Gun Club. The attendees, as well as the performers, all enjoyed the casual atmosphere last year and the Silent Auction was excitingly successful.

Letter from the President:

Summer is here and it's quiet in the Everglades! However, we have continued to stay very busy with our Bank of Everglades project. This letter is to bring you up to date on the progress of our rehabilitation of the building since March.

Our architect, MHK Architects, informed us several months ago that this would be the "slow" time for the project since it was necessary to obtain the results from the geotechnical soil testing before moving forward with the next phase. Soil testing was done on May 23 with results completed this past week. The architect and structural engineer will be providing us with their recommendations to repair the foundation. In the meantime, during the past three months we have accomplished the following:

- Held a very successful Golf Gala at the Naples Depot in March which was underwritten by our new team member Lisa Resch with Carolina Catering Company
- Continued to receive Letters of Support (see https://save-boe.org/supporters)
- Submitted Request Form to Congressman Mario Diaz-Balart for the 2023 Appropriations Community Project Funding
- Coordinated with our Strategic Planner and completed first draft of Case Statement
- Met with Collier County Building Inspector along with MHK Architects and structural engineer at the Bank; he was pleased with progress and plans for rehabilitation
- Established a Bank of Everglades Building Legacy Fund with Collier Community Foundation (CCF) <u>https://cfcollier.fcsuite.com/erp/donate/create?funit_id=4003</u>
- Received feedback from interested individuals regarding our Case Statement which will be considered in the next draft
- Presented to the Everglades City Council and community, updating progress to date with rehabilitating the Bank building as the new Visitor Center / Trail Town Headquarters
- Removed trees on property that were too close to foundation
- Continued to receive donations (\$100 to \$25,000) supporting our Bank of Everglades building plans/project
- Met with Case Technologies (at the request of MHK) to make digital images of the Bank building which will be used in presentations at a national level and will become available for us to include on our website
- Submitted Application to Collier Community Foundation FY23 Capacity Grant for Small Non-Profits
- Submitted Matching Grant to the State Division of Historic Resources Special Category (Awards to be announced Summer 2023)
- Confirmed dates for our 2023 fundraisers Everglades City Homes Tour on March 11 and a Music Festival at the Rod & Gun Club in November

BOARD OF DIRECTORS, 2022 – Brief Biographies

Patricia Huff (President), a retired Financial Advisor with Raymond James & Associates, was a founding member of ESHP which was established to help save the first Collier County Courthouse (now Everglades City Hall). She and her husband purchased their historic 1920s home in 1994. In 2001 Patty founded the City's local newsletter "The Mullet Rapper" and continued as publisher/editor until 2016. Patty is past president of the Friends of the Museum of the Everglades and served as "Historian" on the Collier County Historical & Archaeological Preservation Board from 2005 to 2017. She continues to be invited by county and state organizations to give presentations about the local history of the area. As President Patty leads the organization in strategic planning, oversight of organizational finances, vision, mission, and longterm goal setting. More specifically, over the next several years, she is tasked to oversee all aspects of the reconstruction of the Bank Building.

Kathleen Brock (Vice-President) was born, raised, and lived in Hollywood, Florida, until 2017 when she moved full-time to Everglades City. In 1993, she and her husband purchased a 1920s old-Collier house in Everglades City, and from that moment on, Everglades City became her "home". She is the president of K Bee Marketing, a business consulting firm that specializes in consumer goods marketing, merchandising, and distribution. Kathy is the publisher of our local newsletter "The Mullet Rapper" and publisher of the area website www.visitevergladescity.com. Kathy is a member of the Collier County Tourist Development Board and served on the committee that secured the Trail Town designation for our area. Kathy is very active in the community and is a member of the Everglades Lions Club and a volunteer at the Everglades Community Food Pantry. As Vice President Kathy engages businesses and citizens to support the mission of the organization, as well as creating fundraising ideas and handling all the marketing, publicity, and press releases for events and for the organization (which also includes website administration). Kathy works closely with the President in achieving the organization's goals.

Marya Repko (Secretary) moved in 2000 to Everglades City after she discovered the little planned town in the middle of the swamp and wanted to learn more. She used her background in computers to research the history and has written over a dozen "Brief History" books on the area (website: www.ecity-publishing.com). Marya was a founding member of ESHP and is also on the Board of the Friends of the Museum of the Everglades. She has received widespread recognition as the "authority" on the history of Everglades City and surrounding areas. She is widely respected for her depth of knowledge and is frequently asked to give her popular and well-documented presentations to community organizations throughout the county and beyond. Marya coordinates the meetings of the organization, writing the agenda and taking minutes. She also serves as the membership secretary, coordinating all aspects of ESHP's fundraising projects, sending out acknowledgements to members and donors.

Elaine Middelstaedt (Treasurer), with a law degree and a member of the NJ and FL bars, started her own pension administration business in 1996. She has been interested in historic preservation since she purchased the former two-room schoolhouse in Lordville, NY, in 1973. Since moving to Everglades City in 2001, Elaine has been an active participant and a board member in several community organizations, including ESHP, the Everglades Lions Club, ReachOut Everglades & C.O.P.S. Association, Inc., and the Everglades City Council member for 12 years as well as four years on the Collier County Metropolitan Planning Organization (Chairperson for two years). She is currently Chair of the Citizens Advisory Council of the Collier MPO. As Treasurer Elaine oversees the organization's finances, creating the budget, generating financial reports, and advising the board on financial strategy. She also coordinates with the accountant and the auditor to review finances.

Connie Barker has 25 years of managerial experience in retail, 10 years as the House Manager of the Ronald McDonald House, and completed her career as manager of a multi-physicians practice in Toledo, Ohio. She and her husband visited Everglades City in 1994, eventually purchasing their first home in 1996, moving permanently in 2014. When she retired. Connie decided to dedicate her time in helping others and has been very active in local community organizations: ReachOut Everglades & C.O.P.S., Inc., managing the Thrift Store; Deacon at the Everglades Community Church, assisting with the Everglades Community Food Pantry; and the Lions Club. With her organizational skills and experience, Connie serves as Manager of the Everglades Area Visitor Center which eventually will be moved from the donated space in the Glades Building to the newly rehabilitated Bank of Everglades Building. In addition to welcoming tourists and being a resource to visitors to the area, the Visitor Center / Trail Town Headquarters also promotes local artists by offering their crafts for sale. Connie's responsibilities include recruiting and scheduling volunteers, organizing inventory, coordinating with the artists, and submitting sales reports to the Treasurer.

Helen Bryan was born in Ft Lauderdale, Florida, and lived in that city until she moved to Chokoloskee in the late 1980s with her husband Jim whose father had been pastor of the local church there. She was a founding member of the Friends of the Museum of the Everglades in the 1990s and has been active in every aspect of the Everglades City / Chokoloskee community. With her acquired skills and good eye, Helen was appointed photojournalist of the local newspaper *The Mullet Rapper* in 2014 and continues serving in that capacity. Her ability to capture the history of the Everglades community over the past 30+ years is remarkable. She is everywhere, all the time, behind the scenes at events, chronicling the lives of the people and places of the swamp. Helen is the historian for ESHP, and her photographs are documented on the Gallery page of our website.

Hydie Friend is a retired certified city planner and comes to the ESHP Board with more than forty years of experience using historic preservation for economic development. She has been recognized by her home state of West Virginia and her hometown of Wheeling for her dedication and commitment to community-led preservation and development efforts. Hydie was an early leader in the National Park Service's National Heritage Area movement. Now a Florida resident, she is applying her energy in supporting the efforts of the Everglades Society for Preservation. Historic With her extensive experience, Hydie has been appointed ESHP's Grants Coordinator and manages ESHP's efforts in obtaining grants and funding from various organizations, including state/federal agencies and local private foundations (Collier Community Foundation), communicating, and working together with the consultant grant writer.

Donald Kim joined the ESHP Board in 2022 as it broadens its membership to include more business owners and professionals. He is a recent full-time addition to the Everglades City community, having moved here from Boca Raton, Florida. As a passionate fisherman, Don had been a frequent visitor to the Everglades City/Chokoloskee area over the last twenty years. His current career in the software development field affords him the opportunity to live in Everglades City and work full time remotely. Before getting into the software/computer field, Don spent many years in the hospitality industry and earned degrees in Culinary Arts and Hospitality Management at Johnson & Wales University. Early in his hospitality career, Don enlisted as a food service specialist in the United States Marine Corps. He served in various capacities for eight years, including Mess Hall management, Food Quality Inspection, Recruiting and Information Systems Database Management, ultimately attaining the rank of Staff Sergeant.
