

16th Street NE Bridge Project Details

Collier County Transportation Management Services staff, in coordination with the Florida Department of Transportation (FDOT), District One, are providing the following information to notify project stakeholders, including adjacent property owners and the traveling public, about the 16th Street NE Bridge Project from Golden Gate Blvd. to Randal Blvd. (Collier County Project No. 60212.1 / FPID No. 431895-3). The project includes the construction of a new bridge over the Golden Gate Main Canal on 16th Street NE. There is currently no existing bridge over the Golden Gate Main Canal along 16th Street NE. Additional improvements include widening of existing travel lanes to 11 feet with the addition of six-foot shoulders (four-foot paved plus two-foot unpaved) and a six-foot sidewalk along the entire length of the project. A new traffic signal is also proposed at the intersection of 16th Street NE and Randall Blvd.

The Golden Gate Bridge Canal Crossings at 8th Street NE, 16th Street NE, and 47th Avenue NE Project Development and Environment (PD&E) Study was approved as a Type 2 Categorical Exclusion (Environmental Documentation meeting requirements of the National Environmental Policy Act) and obtained Location and Design Concept Acceptance (LDCA) approval on February 15, 2017. The 8th Street NE Bridge and roadway improvements have been constructed. Furthermore, the 16th Street NE Bridge design is similar to the approved PD&E study Preferred Alternative and the constructed 8th Street NE Bridge Project.

The environmental review, consultation, and other actions required by applicable Federal environmental laws for this project are being, or have been, carried out by FDOT pursuant to 23 U.S.C. §327 and a Memorandum of Understanding dated May 26, 2022 and executed by Federal Highway Administration (FHWA) and FDOT.

The purpose of the project is to provide engineering design and environmental permitting for the improvements to 16th Street NE. The project includes designing a new two-lane bridge over the Golden Gate Main Canal. Following construction, the 16th Street NE bridge and roadway improvements will improve emergency response times and safety along this corridor in Collier County, Florida.

Additionally, a separate project is being constructed for a new road, Vanderbilt Beach Road Extension, that will intersect 16th Street NE between 10th Avenue NE and 12th Avenue NE. This roadway connection will be excepted out and not designed or constructed with this 16th Street NE project.

16th Street NE Bridge Project Schedule

Design for the new bridge and roadway improvements is anticipated to be complete by Summer 2024; Environmental permit coordination and applications are ongoing with South Florida Water Management District (SFWMD) and Florida Department of Environmental Protection (FDEP). Once all permits are obtained, construction will follow. The anticipated schedule and cost for the 16th Street NE bridge and roadway improvements is as follows:

• A new Bridge (No. TBD) will be constructed over the Golden Gate Main Canal along 16th Street NE. The bridge includes two 11-foot travel lanes, a 12-foot shoulder on the east side, and a six-foot sidewalk and six-foot shoulder on the west side.

Anticipated Impacts to the Public

- When under construction, both lanes of 16th Street NE will remain open to traffic along the portions of roadway within the limits of construction.
- Right-of-way acquisition is only required at the intersection of 16th Street NE and Randall Blvd. for this project. The right-of-way will be acquired per existing development agreements.
- Driveway modifications within the Collier County right-of-way will be necessary for those driveways immediately adjacent to proposed bridge and along the project corridor. Other driveways within the limit of construction may incur temporary impacts related to maintenance of traffic.
- There are no planned detours or closures of roads or bridges during construction.
- There are no adverse impacts to the existing drainage conditions and following construction drainage conditions will be improved along the 16th Street NE project corridor.
