## **Collier County Airport Authority**

The department was created in 1993 to oversee the development and management of three publicly owned general aviation airports (Everglades Airpark, Immokalee Regional Airport, and the Marco Island Executive Airport). Since its inception, the Airport Authority has transformed these airports into vibrant public use airports providing a diverse range of services, with each airport offering unique community benefits and opportunities.

## **Communication and Customer Relations**

The department serves both the community externally and county government internally utilizing multi-media vehicles of communication to provide accurate and timely information about county government services and programs, initiatives and projects that improve the quality of life for the county residents and visitors. Staff is responsible for managing the county's Web site and for programming the government access television station, Collier Television, along with the filming and dissemination of meetings held in the Board of County Commissioners chambers.

## **Office of Management and Budget**

Staff responsible for the preparation, implementation and monitoring of the annual operating and capital budgets. To ensure the most effective use of taxpayers' dollars, OMB staff performs budgetary and operational reviews. Additionally, staff provides research assistance and budgetary information to the BCC, county government agencies, citizens groups, and to the general public., and offers support to the Productivity Committee.

## **Pelican Bay Services - Director John Petty**

The Pelican Bay Services District operates and maintains the infrastructure within the Pelican Bay Planned Unit Development with the exception of the roads and sidewalks.

## **Tourism Department – Director Jack Wert**

Staff is responsible for overseeing more than \$13 million in tourism tax brought into the county by over 1.4 million visitors per year. Visitors spend on average, \$713 million per year in the destination, providing a total direct and indirect economic impact of over \$1.06 billion to the County's economy.

With respect to this, staff continues to develop and disseminate the annual All Hazard and Home Protection guides and participates in training Community Emergency Response Teams and Disaster Preparedness Programs each year.
