Thank you for taking the time to express your thoughts and concerns on the Vanderbilt Drive sidewalk project. The Vanderbilt Drive sidewalk project was identified as a safety need in 2017. The Collier County Metropolitan Planning Organization (MPO) prioritized and approved this project for design and construction in 2018. All five County Commissioners sit on the Collier County MPO Board. The proposed sidewalk will be in County Right-of-Way (ROW) and not on private property, therefore none of your property will be taken. The distance the existing houses sit from the roadway is not changing, nor are the right-of-way lines. Existing setbacks and property lines are not changing. Concerning the cost of the project, the County received a grant from the Florida Department of Transportation to design and build this project. Michael P. Tisch, PMP, FCCM

Comment sent via email on 2/4/2024: I received a flyer at my door with some basic information from a PIM held on 1/18/24. I was out of town all last week so this is the first I've seen anything on this project other than when it was mentioned in our December DSAC meeting. I live on 111th Ave north. My wife said the woman who dropped off the flyer stated that the plan was to take additional ROW on each side of 111th. It is already difficult for us to park a vehicle between the sidewalk and the road, so any additional taking would be hugely detrimental to our property. Could you please provide the design plans for the 111th portion of the project that I could review? Thanks so much for any assistance you can provide.

Email received on 2/5/24: That's what I figured, but it effectively does put the road 5' further into our driveway. How are we supposed to park vehicles between the existing sidewalk and the new bike lane?

It's dangerous enough right now trying to back out of our driveway avoiding pedestrians on the sidewalk and now we're adding a bike lane to the mix. Why not move the sidewalk out to the EOP where it belongs with some type of curb? Another Email received on 2/5/24: I understand that it's free money and I'm not arguing whether a bike lane is needed. My point is has anyone looked at the full implications of this "quick fix"? Drive the road and see how many people have to park cars in that portion of our driveways - pinned between the road and the sidewalk. This change brings everything closer to our vehicles and houses. Cars will use the bike lane to go around other traffic, etc. This may be making biking less dangerous, but it's creating new safety issues. 111th should be dealt with wholistically to solve the issues instead of this band aid. The ditch should be underground, the sidewalk should not bisect the middle of properties, etc. Why not put a 10' multi-use pathway on the north side of the road where no one lives? It's only grass & landscaping for the entire length and has no impact on residences.

No right-of-way (ROW) is being taken for the project. The project is constructing 5-foot Bicycle Lanes on 111th Ave from the Blue Bill bridge to 7th St. N. all within the existing ROW. As requested, I have attached a set of the construction plans.
