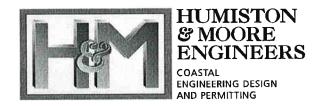
ADVISORY COMMITTEE RECOMMENDATIONS: On April 12, 2007 the CAC recommended approval of this item 8 to 0.
