- The sign may be affixed to the building, or free-standing in front of the building so long as the sign does not obstruct pedestrian traffic, interfere with vehicular traffic, parking or fire lanes, or obstruct access to adjacent units
- Free-standing signs must be at least 10 feet from any right-of-way line and/or any property line
- The sign must be constructed of wood, plastic, or other similar material, and *may not* be a banner sign
- The sign area must be limited to 16 square feet
- The sign copy is limited to the name of the business
- If in a shopping center or multiple occupancy building, the sign for each business must be of similar color and lettering
- The sign may remain in place for no longer than 120 days, or until construction has been completed, whichever occurs first

The Temporary Use Permits for temporary business identification signs will not reduce the number of days allowed the business or shopping center for Temporary Use Special Event permits.
