# **MedCenter Update**

Three months after opening its doors, the MedCenter has served over 800 employees for the following medical issues:

- cough, cold and flu
- routine physical exams
- skin problems
- high blood pressure
- digestive problems
- respiratory issues
- insomnia
- minor accidents
- routine injections

The MedCenter is a newly created primary care facility, located in the Risk Management Building at the Collier County Government Center that provides employees who are currently covered under the Group Health Plan with a convenient medical care alternative.

"Employers are beginning to see that a high quality, convenient health care delivery alternative such as the MedCenter is a good way to keep employees healthy," said director Jeff Walker, Risk Management. "Employees really appreciate having a medical clinic of their own to serve their health care needs."

Recently, one employee told Walker, "Thank you for providing the clinic to our employees. This is the greatest thing in the world! Lily Fotiadis (the nurse practitioner) is outstanding!" Walker announced that effective Monday, April 16, the MedCenter will begin offering general heath services

adult children (over age 17) by appointment.

As for the future, Walker said that staff is reviewing the use of the MedCenter to create a "patient advocacy model," which would "integrate the wellness assessment and education ef-

forts that Marilyn Hamachek offers with direct care management and coaching through the MedCenter to employees who have chronic health conditions or who have the potential to develop such conditions."

"We would like to close the loop between assessment and care delivery," Walker said. "We are also taking a look at using the MedCenter on a limited basis for certain non-specialized Workers' Compensation cases of an acute nature. That will be decided in the near future." # **Employee Culture Survey**

Eighty-eight percent of employees in the County Manager's Agency clearly understand their job responsibilities; 86 percent believe the county has clearly communicated its ethics policy to all employees and 83 percent of county employees get a sense of personal accomplishment from their work. Those are some of the findings in the 2007 Climate Survey conducted by Human Resources between Feb.1 and March 1. The survey produced 1,112 employee responses. HR also received 110 pages of comments and three copies of the comments are available for review at the HR office. The answers and comments will be used to devise programs that will make Collier County Government an even better place to work.

### **NEOGOV** has arrived



Human Resources unveiled NEOGOV, the new online employment application and recruitment system, in February.

"The new process is completely automated, and can be accessed (postings and user accounts) through any computer that is connected to the Internet," said Operations Manager Amy Lyberg, Human Resources. "It allows the applicant *more flexibility* and *instant access* to all submitted applications, meaning that users can log into their accounts and see the status of each submitted application and track the recruitment process."

For those employees who do not have access to computers to apply online, the Human Resources' office, Building B, offers computer service Monday through Friday from 7:30 a.m. to 5:30 p.m.

"We received 1,300 applications in the first 30 days, and our applicants have been pleased with the immediate feedback they are able to get regarding their application and to receive updates as they move through the recruitment process," said Lyberg.

## **Combating Pandemic Influenza**

Pandemic Influenza is defined as a global outbreak of disease that occurs when a new influenza "A virus" appears in

humans, causes serious illness or death, and then spreads easily from person to person worldwide.

Collier County and many other governmental and private industry emergency response agencies have been proactive for several years in trying to prepare for the potential effects of a pandemic, and most recently planned and designed a tabletop exercise in conjunction with a full-scale pandemic influenza exercise known as "Operation Pan Plan 2006."

"Operation Pan Plan 2006" was designed primarily to demonstrate and test the capabilities of several emergency response authorities and agencies to effectively respond to and mitigate an operational emergency, requiring liaison and coordination with numerous support agencies.



"We learned from our mistakes as well as our successes during this event and will incorporate this knowledge into our current plans and processes," said Joe Frazier, special projects coordinator in the Emergency Management Department. "I strongly encourage everyone to learn more about what they can do to better protect themselves in the event of an outbreak."

The Bureau of Emergency Services, The Department of Health, local hospitals and many other agencies can provide citizens with a multitude of educational materials designed to help them prepare for potential events such as a pandemic. For more information call 774-8000.



# Ossorio Selected as Employee of the Year

Mike Ossorio, contract licensing officer in the Community Development and Environmental Services Division, was selected Collier County government's Employee of the Year for 2006.



As one of four contract licensing officers working for Collier County government, he manages and directs all matters pertaining to Collier County licensing ordinances, researches, inspects and investigates complaints, as well as educates contractors about licensing requirements, policies and procedures.

"Most of the time I receive complaints that involve licensed and unlicensed contractors who have received large deposits of money for jobs under contract where very little work or no work at all has been performed," said Ossorio. "Unfortunately, many of the clients I help are elderly individuals who are targets of scam artists and unscrupulous contractors. Often times my clients have purchased goods and services that are not needed, and charged highly inflated prices."

In addition to responding to client complaints, he works closely with the City of Naples Building Department to check job sites for unlicensed activity and contractors working without permits. He also meets with local contractors to update them about changes in state laws and insurance requirements.

"In the last seven years, Ossorio and his team have recovered and returned over \$1 million to Collier County citizens," said Director Bill Hammond, Building Review and Permitting Department. "Mike's performance is the perfect example of *exceeding expectations* in action. His concern for the citizens of Collier County and his performance as a team player are exemplary and serve as a role model for all employees."
