

Only about 30% of a Collier County Resident's tax bill pays for County Government. Other agencies such as the School Board, South Florida Water Management District, or Fire Districts often make up the remainder.



- Expanded funding for Tourism marketing and promotion




## REDUCTIONS/CHANGES

- Received \$42 million in Federal Stimulus funding, including \$3 million for Energy and Conservation projects


### GENERAL FUND REVENUE

The largest source of revenue for the General Fund is Ad Valorem - or property tax revenue; Constitutional Officers make up about 51% of the expenses. Compared to Fiscal Year 2009, the General Fund Budget has decreased by \$35,622,700 or about 9.6% in Fiscal Year 2010.
