In accordance with Rule 9J-11.011, F.A.C., Collier County is transmitting three (3) copies of the adopted Remedial Growth Management Plan amendments, including support data, to the Department of Community Affairs (1 hard copy, 2 CDs). The Collier County Board of County Commissioners reviewed these Growth Management Plan amendments in an advertised public hearing on December 14, 2010, and approved them by adoption of Ordinance Number 2010-

Included in this submittal are three copies of the "clean" pages of the amended Elements and map to be inserted in your Collier County Growth Management Plan documents upon their effective date.

One copy of this entire submittal package of adopted amendments (except for the courtesy sign-up sheet regarding notification of the Notice of Intent) is being sent, on the same date as this letter, to the: Southwest Florida Regional Planning Council; Florida Department of Environmental Protection; Florida Department of Transportation, District One; South Florida Water Management District; Florida Department of State/Bureau of Historic Preservation; Florida Fish & Wildlife Conservation Commission; and, Florida Department of Agriculture & Consumer Services/Division of Forestry.

Amendments to the following Elements are included in this submittal:

- Future Land Use Element and Future Land Use Map Series; and
- Conservation and Coastal Management Element.

These amendments are *not* applicable to the Big Cypress Area of Critical State Concern, and are *not* adopted under a joint planning agreement pursuant to Ch. 163.3171, F.S.

These amendments *are* exempt from the twice per year limitation on adoption of comprehensive plan amendments as set forth in Rule 9J-11.006(1)(a)7.d. (pursuant to a compliance agreement).

Collier County has previously sent its complete adopted comprehensive plan, including amendments and support documents, to all agencies identified in Rule 9J-11.009(6).

The Florida Department of Community Affairs should publish its Notice of Intent in the Naples Daily News.



Pursuant to Chapter 163.3184, F.S., the Collier County Board of Commissioners hereby requests that the Department of Community Affairs conduct a review of the Plan Amendments transmitted herewith, and the State's subsequent final determination of compliance.

Included in this submittal (DCA copies only) is the "Comprehensive Plan Citizen Courtesy Information List" sign-up sheet from the adoption hearing of the Collier County Board of County Commissioners, relative to receiving notice from DCA when the Notice of Intent will be published (there are no names listed as there were no speakers at the hearing and no correspondence received).
