Draft FY2011/12 - FY2015/16 Transportation Improvement Program (TIP) Public Comment Period Announced

The Collier Metropolitan Planning Organization (MPO) is announcing the opening of a 30-day public comment period for the Draft Fiscal Year (FY) 2011/12 through FY2015/16 Transportation Improvement Program (TIP). The MPO Board will be asked to adopt the FY 2011/12 through FY2015/16 TIP with consideration of all the comments received during the public comment period. A public hearing will be held on the FY 2011/12 through FY2015/16 TIP in conjunction with the MPO's regular meeting on May 13 at 9 a.m. in the Board of County Commissioners chambers, third floor, Collier County Government Center, 3299 Tamiami Trail East, Naples.

Pursuant to the MPO's Public Involvement/Public Participation Plan, the draft FY 2011/12 through FY2015/16 TIP is made available for a 30-day public comment period. The public comment period for this Draft FY 2011/12 through FY2015/16 TIP began on April 5 and will end on May 5, 2011. Each year, the MPO is required to develop a financially feasible TIP that includes all items that are to be funded with state and federal dollars over the next five years. The MPO's endorsement of this Draft FY 2011/12 through FY2015/16 TIP is needed so that all projects within the TIP might be recognized and qualify for all federal and state funds that become available. This Draft FY 2011/12 through FY2015/16 TIP includes projects for highways, aviation, transit, the Transportation Disadvantaged Program, Transportation Enhancement projects, and transportation planning projects. Highway projects that are included in the TIP must be derived from the MPO's *Long Range Transportation Plan*.

In addition to FDOT's Five-Year Work Program, a TIP is required to include the Capital Improvement Programs for Collier County and the municipalities of Naples, Marco Island, and Everglades City for informational purposes only.

The MPO's planning process is conducted in accordance with Title VI of the Civil Rights Act of 1964 and Related Statutes.
