Overall Progress Narrative:

Collier County continues to administer the NSP1 with success. The program remains in a stage focused less on acquisition and more on rehabilitation and resale of acquired properties. The County is also seeking non-profit providers of affordable housing to operate the multi-family rental component of the program; this component will serve the LH25 population of the NSP1. Once homes are resold to income-qualified households, generating program income, additional properties will be acquired.

As similarly encountered last quarter, Collier County was unable to resolve a persistent error within DRGR. The error continues to relate to the system&rsquos inability to match cumulative to date for breakout categories. Collier County sent staff to a DRGR training, as well as conducted online research in how to resolve the persistent error. It is now believed that in order to correct the error, HUD will have to reject each previously submitted QPR so that Collier County may corrected the cumulative total and expected total performance measures; the measure as currently entered do not match across measures, thus it is believe it is not possible enter any combination of data to resolve the system error.

Collier County has completed a reconciliation of each quarter&rsquos data (both financial and performance measurement) and is ready to begin the correction period. However, in order to comply with the requirements of NSP, this QPR is being submitted on the required due date. Once the reporting period closes tomorrow, Collier County will contact our HUD representative to begin the correction process. Additional support from the DRGR team may be required to resolve this problem.
