

CHECKLIST FOR: Fence Permit

General Submittal Requirements

- □ Permit Application.
- Owner/Builder Disclosure Statement. This is required when an owner is obtaining a permit.
- □ **Notice of Commencement.** A certified copy is required if job value is \$2,500 or greater prior to the first inspection (this is not required to be submitted to obtain the permit)
- □ **Health Department.** If there is a septic system located on the property, a site plan must be provided showing the location and distance of the tank and drainfield to the proposed fence.

Additional submittal requirements may be required. Prior to receiving a processing number from the Customer Service Representatives, all plans must be assembled properly.

Submittal Requirements for all 1 & 2 Family Permits:

- □ **Site Plan.** Two copies of the site plan indicating the property lines, roadways, water ways, easements, existing structures, and proposed fence location, height, and type of material
- □ Vegetation Removal Affidavit. Required if woody vegetation will need to be removed
 - One acre of vegetation is allowed to be removed after the single-family building permit has been issued. A Vegetation Removal Permit is required to clear over one acre.
 - The Vegetation Removal Affidavit is required to be turned in with, but not limited to, the following: Any Structure, Buildings, Chickee Huts, Storage tanks, Carports, Temporary Construction Trailer, Wood Deck, Demolition, Driveway, Fence, Pool, Slab, Tennis Court Permits, and Seawalls.
- □ **Preservation Review Form.** Required if the property is located in the Rural Fringe Mixed Use district
- **HOA Letter.** Provide an approval letter for the following communities:
 - Carson Lakes

• Victoria Falls

- Liberty Landing
- Independence

- Trail Ridge
- Charlee Estates

CHECKLIST FOR: Fence Permit

- □ Fences and Walls Requirements. Fences and walls shall be constructed to present a finished side of the fence or wall to the adjoining lot or any abutting right-of-way. See LDC section 5.03.02 for additional information regarding Fence and Wall requirements.
- □ **PVC, Aluminum, or Vinyl.** For fences constructed of PVC, Aluminum, or Vinyl, provide the product specifications.
