

# PENSION REFORM

Collier County's Tallahassee lobbyist, J. Keith Arnold & Associates, provides this update regarding pension reform legislation now being considered in the legislative session which runs through May 6.

Governor Rick Scott is on record stating that neither the House nor Senate versions of FRS pension reform go far enough – stressing that he would like to see a flat 5 percent defined contribution. The Senate passed its version (SB 2100), setting up a tiered system of retirement contributions. Employees would contribute 2 percent on their first \$25,000 in compensation. Further compensation up to \$50,000 would require a 4 percent employee contribution. Wages and benefits over \$50,000 would require a 6 percent contribution.

An amendment was approved that changes the contribution tiers for

elected officials to 3 percent for wages and benefits under \$25,000, 5 percent for compensations up to \$50,000 and 7 percent for compensation over \$50,000.

The House proposal calls for a flat 3 percent contribution for all FRS employees. It also ends the DROP early retirement program for state employees. The Senate version delays for five years the closing of the DROP program. The House bill increases the retirement eligibility for initial enrollees from age 62 to 65 or from 30 to 33 years of service. The Senate bill maintains the existing retirement age.

The differing pension bills are now in conference committees between the House and Senate. These committees are expected to begin meeting after the Easter/Passover break next week.

# Collier Area Transit Celebrates 10 Years of Service

Collier Area Transit (CAT) recently celebrated its 10th anniversary with an open house and free rides on all bus routes for one day. Collier Area Transit began operations in February 2001 with seven buses traveling five fixed routes, six days per week. Within

six, short years CAT's ridership exceeded more than one million passenger boardings per year utilizing 20 buses covering seven fixed routes with expanded service to

include Sundays on most routes. At age 10, CAT continues to serve over one million passengers per year with 23 buses serving 10 fixed routes Monday through Saturday and eight routes on Sunday. When CAT started service, interested riders flagged the buses down to board since there were no bus stop signs, shelters or benches and now there are approximately 50 shelters and over 480 bus stops with signs along the 10 fixed routes.

CAT was able to add two new hybrid electric buses to its fleet last year with a \$1.2 million American Recovery & Reinvestment Act (ARRA) grant. The new buses are more fuel efficient, quieter and lower in emissions than standard type buses. All CAT buses are equipped to handle wheelchairs and each bus has a bicycle rack on the front.


### Collier County MedFlight Adds New Safety System

Collier County MedFlight has recently added a new safety enhancing system

to their air ambulance helicopter. The new system provides both a visual and audio warning to the pilot of potential hazards to flight such as towers and if the aircraft

is descending dangerously close to the ground. The Helicopter Terrain Awareness and Warning System or HTAWS is similar to what is available for commercial airliners but has been modified according to Federal Aviation Administra-

### Facilities Management Hosts Seminar

The Facilities Management Department recently hosted a Sheriff's office seminar on fraudulent documents. Within one hour after the seminar, Facilities Operations Center staff recognized what appeared to be fraudulent drivers licenses submitted by employees of a local construction contractor doing work for the county. Five individuals had come in to get their Contractor's ID Cards (as part of the fingerprinting process they must show their DL's).

Facilities staff called the Sheriff's Office who dispatched four deputies. The result? Three people were arrested on felony charges and were placed into custody.

### HOUSING, HUMAN & VETERAN SERVICES RECOGNITION

Collier County was among 14 communities across the country presented with the Gabe Zimmerman Award for Public Service during the 2011 National Community Development Association (NCDA) Legislative and Policy Conference in Washington, D.C. The award recognizes communities which have used the Community Development Block Grant (CDBG) Program or the HOME Investment Partnerships (HOME) Program in an exemplary fashion to better the lives of low-income people and neighborhoods.

"We feel so honored yet humbled for receiving this award which recognizes an outstanding Community Development Block Grant project - the Fun Time Early Childhood Academy," said Marcy Krumbine, director of the Collier County Housing, Human and Veteran Services Department.

Founded in 1961, Fun Time was housed in a double-wide trailer until Hurricane Wilma dealt a devastating blow to the aging structure in October 2005. A campaign to build a new 8,000 square foot facility received funding support from FEMA, Naples Children and Education Foundation, and the City of Naples while Collier County contributed \$275,000 of its CDBG funds.

"We are very proud of Marcy and her staff as the Fun Time project is a prime example of developing relationships, overcoming obstacles together and working cooperatively to achieve a common goal that benefits the residents," said County Manager Leo Ochs.

# **BLIGHT PREVENTION**

More than \$2 million has been expended by banks and lenders to eliminate code violations under Collier County Code Enforcement's nationally-recognized Blight Prevention Program.

There have been more than 21,000 foreclosure filings in Collier County since January 2008. Code Enforcement has been proactive in its efforts to work with constituents and neighborhood partners to address the problems associated with foreclosures.

"When foreclosed properties are identified with code violations, our investigators take a win-win compliance approach and resort to traditional methods only if banks and lenders do not take responsibility for their properties," said Code Enforcement Director Diane Flagg. "The Blight Prevention Program is intended to help stabilize property values by keeping properties maintained by banking institutions through voluntary compliance."

Banks have voluntarily abated 1,681 code violations through April 17, 2011 with abatement costs paid by lenders totaling \$2,083,925.



# **Process Improvement**

SIRE Technologies recently noted Collier County's use of their system to track insurance certificates based on coverage schedules set forth on each certificate rather than by the date of the contract, the way it has been tracked in

the past. This followed the work of a cross functional process improvement group led by Collier's STEP-UP Team that recommended an improved process and taking advantage of the available workflow system. They consequently avoided spending tens

of thousands of dollars, as compared with purchasing a commercially available product. In addition, the team estimates a savings of at least \$40,000 in staff time that can be redeployed to other functions, improving the productivity of the county's workforce.

"The issue of insurance certificate

tracking and its associated risk is one we have struggled with for some time. The result has exceeded my expectations in terms of functionality and certainly in terms of cost. We are very pleased," said Risk Management Di-

rector Jeff Walker.



Strategic Excellence Program for Ultimate Performance Purchasing and Risk Management officials recognized that most proof of insurance certificates are valid for only one year, but many county projects take longer than one year to complete. According to County

Records Manager, Michael Cox: "This resulted in the potential for a lapse in required insurance coverage because vendors did not consistently ensure that their coverage was updated prior to expiration." To solve this issue and eliminate associated risk, Collier County created a SIRE document cabinet strictly for insurance certificates. When a new certificate is added to the cabinet, the customized SIRE workflow is triggered. The workflow determines whether a project is still open and whether the related insurance certificate is about to expire. If both criteria are true, a system-generated email is automatically sent to the vendor 15 days prior to the expiration date. If the document is not renewed at that time, a second notification is sent five days prior to expiration.

"This change means we are further minimizing gaps in insurance coverage and are doing so in a simple, more cost effective environment," said Purchasing Director Steve Carnell. "Michael Cox and Brenda Reaves deserve a lot of credit for putting this system together."


