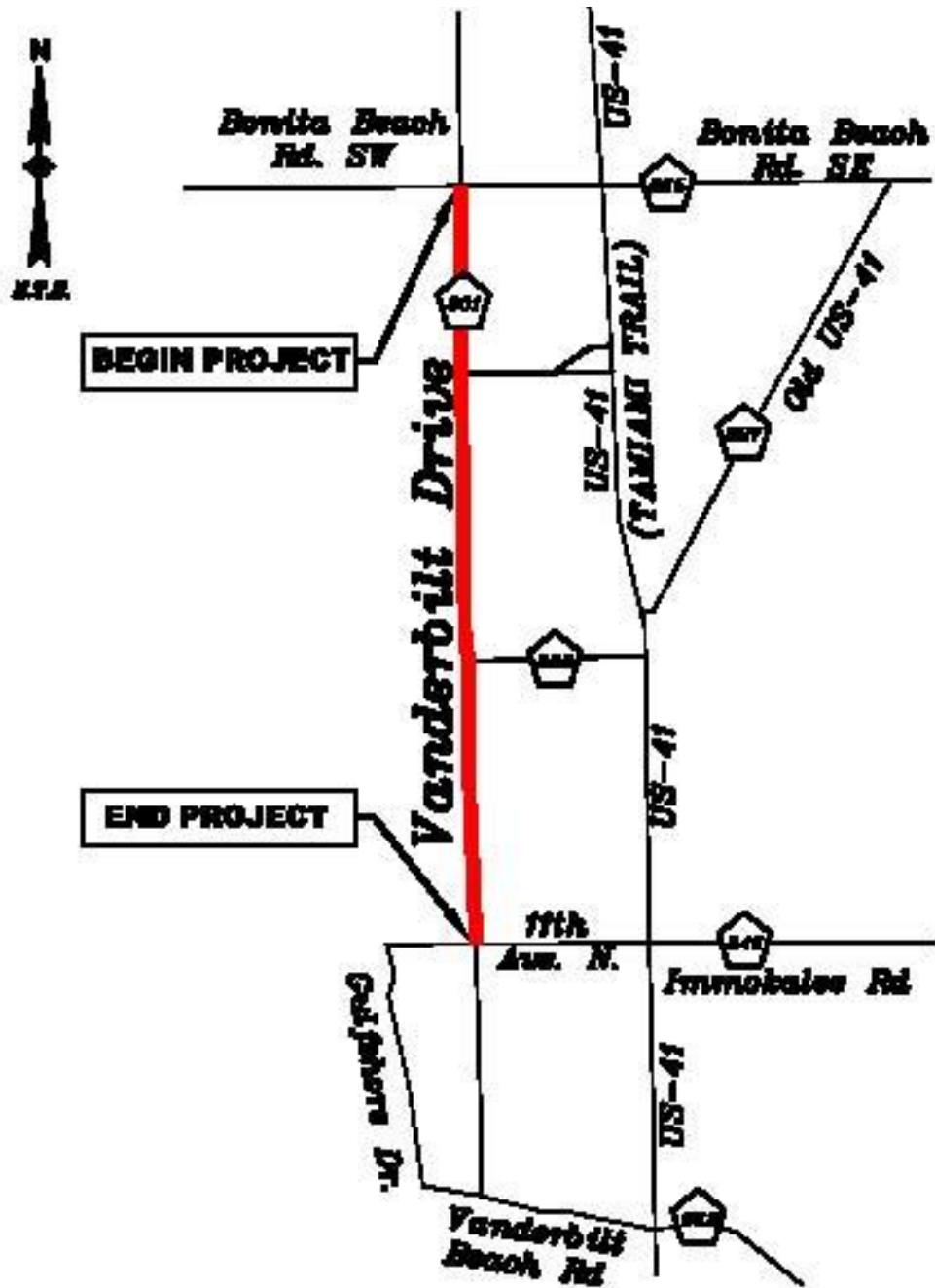

## **Vanderbilt Drive Pathway Project Details**

- The pathway will be done in coordination with the Public Utilities Water Main Replacement Project and the Vanderbilt Beach Beautification MSTU's FP&L Underground Power Conversion Project.
- Construction could be phased with start dates to be determined.
- Project limits are from 111<sup>th</sup> Avenue North to Bonita Beach Road (approximately 4 miles).
- Informational signage will be provided along the trail. Signage will include directional signage, rules/safety, general information, and environmental considerations.
- Consideration to minimizing environmental impacts has been made in the design and plans for construction of the project.
- The proposed pathway surface is asphalt for capital cost effectiveness, reduced maintenance cost and because it is a multi-user friendly surface.
- **Permanent Easements:** Construction is proposed primarily within the existing rights- of-way on the west side of Vanderbilt Drive. However, permanent easements may be proposed along the pathway.
- **Temporary Construction Easements (TCE):** Temporary construction easements may be needed for the construction project, pathway/sidewalk or water/utility lines.
- **Width:** The proposed improvements to the trail are to increase the width to an 8 foot wide pathway. The original width of 10-12 feet was reduced based on public input from the surrounding communities.
- **Costs:**
  - Pathway project cost: estimated at approximately \$570,000 - \$640,000. Final project costs are expected to change. Due to the current economy it is our experience that contractor bids are coming in below the engineer's estimate.
  - FP&L project cost: Current estimated cost for the underground power conversion is \$850,000.
  - Public Utilities Water Main Replacement cost: This project is still in the initial phases therefore the cost is to be determined.

\*Due to projects being completed together, the costs may decrease in comparison to completing the projects individually.
