occurred that would affect the proposed permit activity.

- 9. The construction and maintenance of said activity shall not interfere with the property and rights of a prior Permittee. It is expressly stipulated that this permit is a license for permissive use only and that the placing of facilities upon public property pursuant to this permit shall not operate to create or vest any property right in said holder.
- 10. Whenever necessary for the construction, repair, improvement, maintenance, safe and efficient operation, alteration or relocation of all, or any portion of said highway as determined by the District Director of Operations, any and all facilities and appurtenances authorized hereunder, shall be immediately removed from said highway or reset or relocated thereon as required by the Director of Operations. This will be accomplished at the expense of the Permittee.
- 11. It is understood and agreed that the rights and privileges herein set are granted only to the extent of the State's right, title and interest in the land to be entered upon and used by the Permittee. To the extent allowed by Section 768.28, Florida Statutes, the Permittee will, at all times, assume all risk, indemnify, defend and save harmless the State of Florida, the Department's officers, agents and employees from and against all claims, demands, action, liabilities and suits of any nature whatsoever arising out of, because of or due to the Permittee's use (or use by its agents or employees) of Department R/W. This will include any and all loss, damage, and cost or expense arising in any manner on account of the exercise or the attempted exercise by the Permittee of the aforesaid rights and privileges. This will include any act or occurrence of omission or commission by the Permittee, its agents or employees. It is specifically understood and agreed that this indemnification clause does not cover or indemnify the Department for its negligence.
- 12. During construction, all safety regulations of the Department shall be adhered to and the Permittee shall be responsible to provide measures, including placing and display of safety devices, that may be necessary in order to safely conduct the public through the project area in accordance with the federal manual on uniform traffic control devices (MUTCD), as amended, and the Department's latest roadway and traffic design standards.
