Hi Debbie,

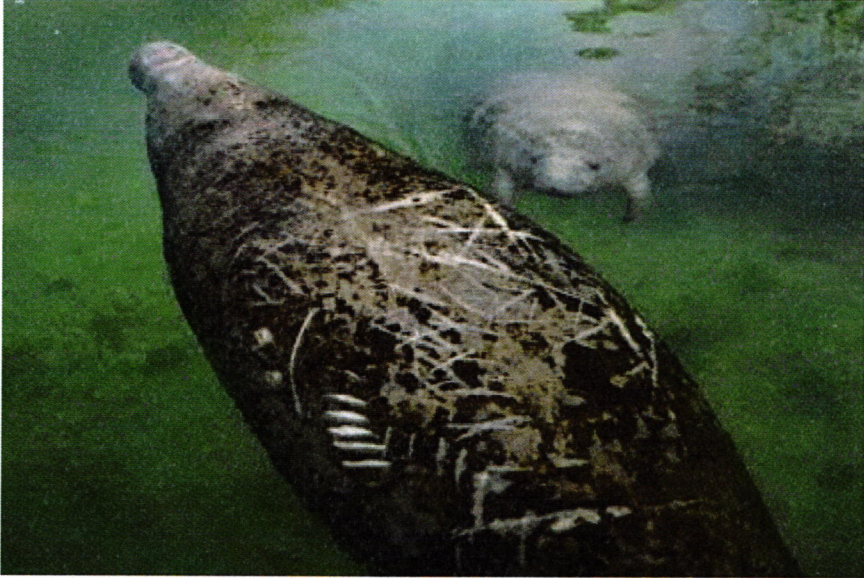
Since I haven't heard back from you I was just wondering if you received my emails dated April 2nd and April 3rd?

Dear Debbie,

As a Manatee Protection Committee member, I feel we are concentrating too much on the *location* of the manatee carcasses (manatee mortalities), despite being reminded often by Scott Calleson that the locations shouldn't be thought of as the place where the manatees were killed. I also think that the manatee zones should take into account not just the overlap of boaters and manatees, and manatee mortalities, but the number of injured and/or rescued manatees.

In that regard, would you please let me know if articles / reviews are available for the following topics:

1. Number of manatee injuries and/ or rescues in Collier County and adjacent counties for 2000 - 2016
2. Average number of prop scars per manatee
3. Current MIPS information - number of manatees currently in the photo identification system

Also, might the following be printed and made available to each committee member for the meeting next week?

1. Review: Slower boat speeds reduce risks to manatees, by Scott Calleson and R. Kipp Frohlich, 2007
2. A copy of a photo showing the tracking of 2 manatees with telemetry tags that shows their traveling path from Marco Island to Port of the Islands within 6 days to a week. I'm thinking of a specific photo, however it can be anyone that shows that manatees travel distances in relatively short amounts of time. My goal is to show that a manatee that was injured or struck by a boat in one location, might actually die in a location many miles away as we have been reminded of frequently during our meetings by Scott Calleson.
