HEARING EXAMINER STRAIN: Good morning. Welcome to the meeting of the Hearing Examiner's Office.

Item 3, Approval of Prior Meeting Minutes, January 28, 2016. Those have been reviewed and they are good to be recorded as submitted.

Which takes us to our first advertised public hearing. It's Petition No. BD-PL20150001918. It's the Bob Mosley boathouse in Vanderbilt Beach Estates.

HEARING EXAMINER STRAIN: My disclosures on this: I've talked with staff, I've reviewed the files, spoken with the attorney this morning, Greg Nelson.

Maybe it's something we should consider as an LDC amendment going down the road. So a lot of time consumption that I can't find the necessary for. Staff certainly has the capabilities of reviewing

against the code.

So, with that in mind, are there any members of the public that have any comments on this?
