

The Foundation for the Developmentally Disabled, Inc. (FDD) and Community Assisted and Supported Living, Inc. (CASL) each own multifamily housing properties that were acquired with NSP 1 funds. Each organization has a Subrecipient agreement with Collier County to insure that the properties continue to offer an affordable rental option to low income residents in the community.

A transfer of ownership of the FDD owned properties to CASL is being organized at this time. On February 9th the Board of County Commissioners are scheduled to review, acknowledge and approve an Assignment, Assumption and Amendment Agreement between FDD and CASL. The Agreement will assign the duties and obligation of the NSP subrecipient agreement between Collier and FDD to CASL and clarify the required affordable rent limits.
