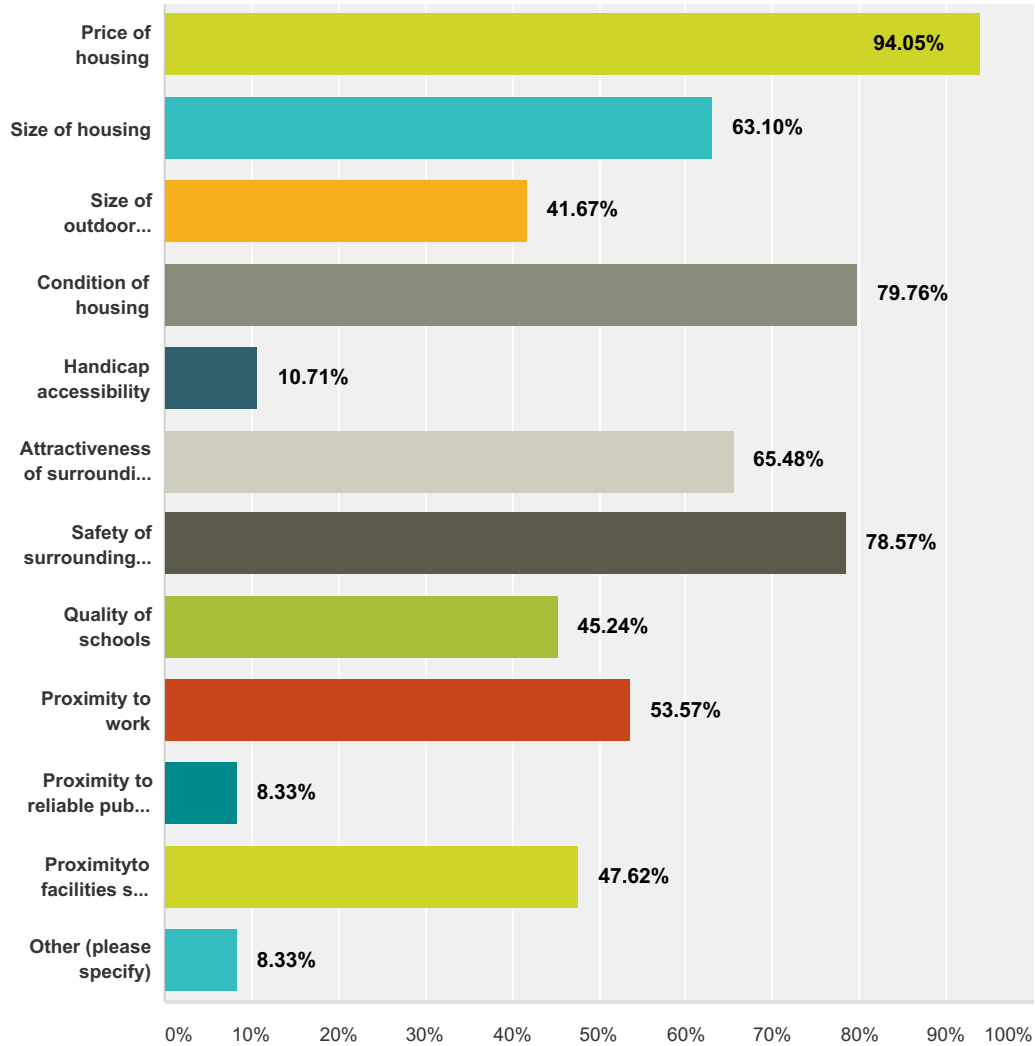

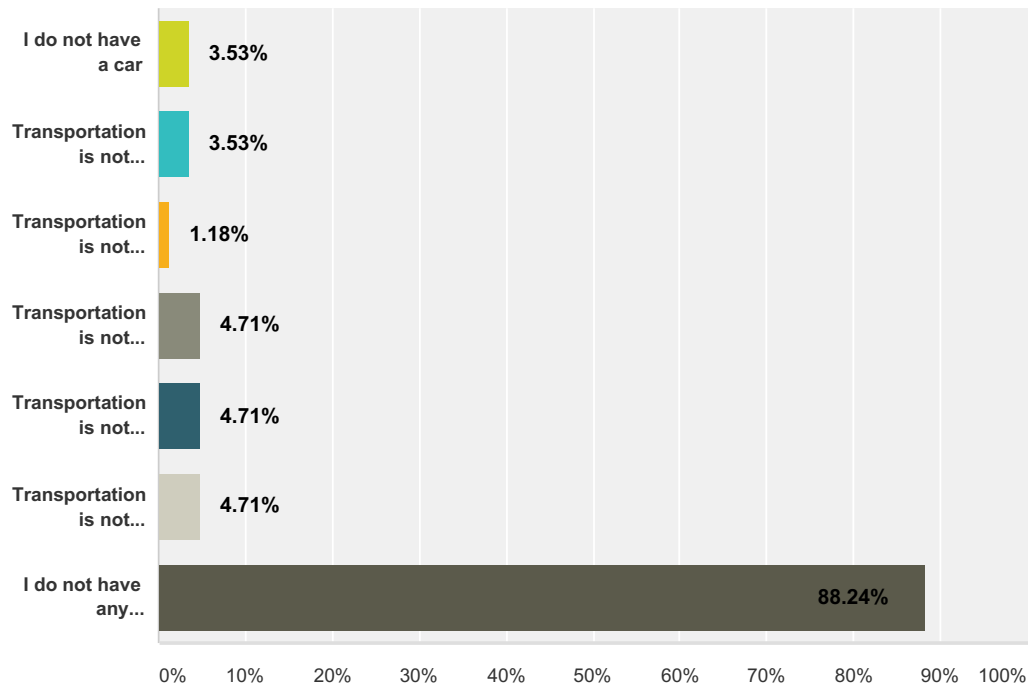

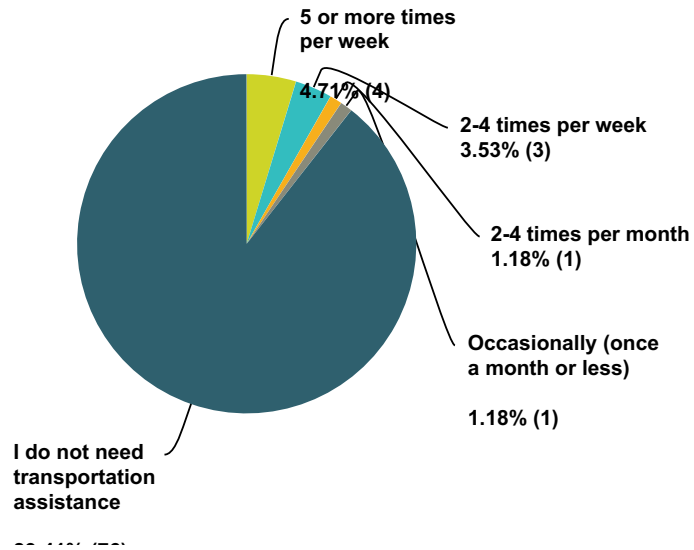

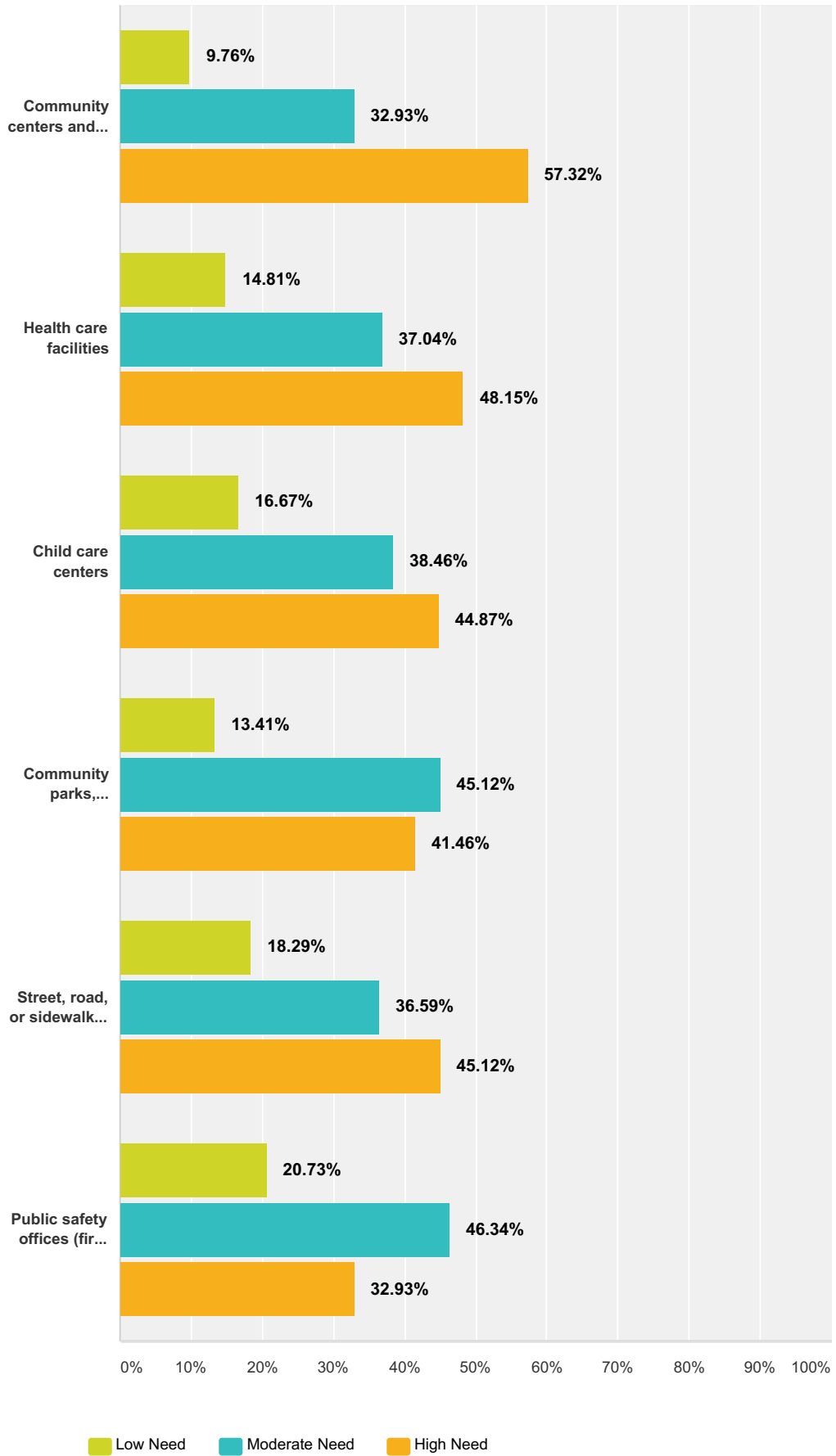

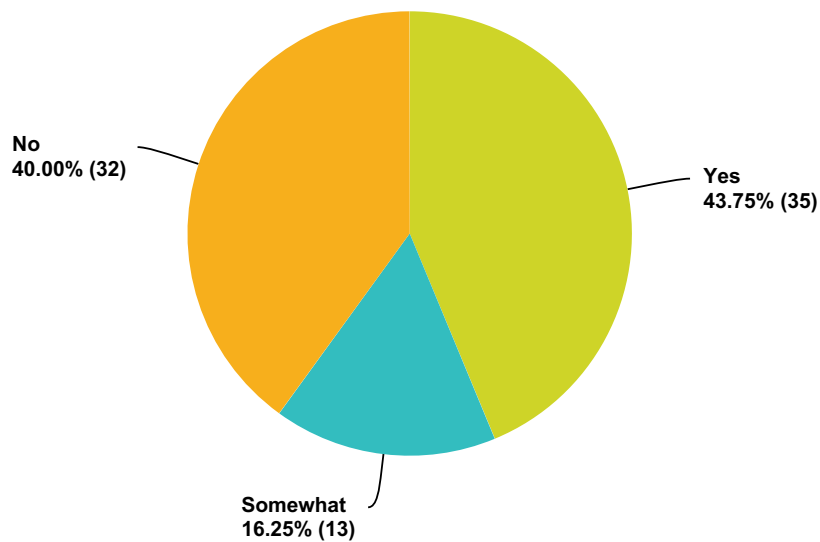

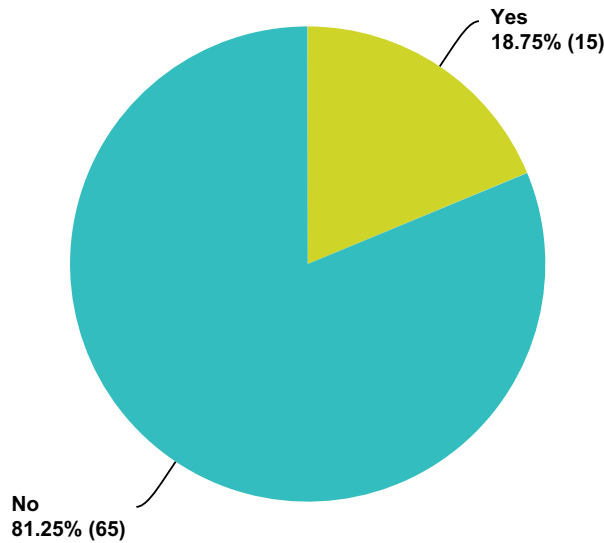

Offer additional property tax exemptions to county residents; 2. Eliminate costly fees; 3. Create a general fund (blanket) to eliminate the high cost of private insurance for the Developers, Builders and homebuyers; 4. Request that the members of NABOR consider reducing the current commission percentage rate; 5. In exchange for a certificate so the reduced amount may be reported as a business expense on the Federal tax return. This in turn will make the closing costs affordable for the low income homebuyer; 6.
