

Issues of Major Importance:



EMS Station at Mile Marker 63

NEED: Provide long-term revenue stream to cover operating costs for the Collier County EMS Station at Mile Marker 63. **ACTION:** Amend section 338.26, Fla. Stat., for Alligator Alley toll revenue share to fund EMS Station at Mile Marker 63.



Southwest Florida Promise Zone (SFPZ)

NEED: Support the mission of the Southwest Florida Promise Zone, to improve economic opportunity through education; crime prevention; infrastructure; and economic development. **ACTION:** Educate and mobilize elected officials to support projects within the SFPZ.



Rural Area of Opportunity (RAO)

NEED: Leverage the recently renewed Rural Area of Opportunity (RAO) designation for Immokalee to secure State funding and access to State programs.

ACTION: Leverage State funds secured through the RAO program to bolster SFPZ initiatives.



Collier County Restore Comprehensive Watershed Improvement Project

NEED: Improve water quality to rehydrate 10,000 acres of the Picayune Strand State Forest and restore historic freshwater flows to Rookery Bay.

ACTION: Secure approvals and permits from State agencies.



Workers Compensation Insurance Reform

NEED: Mitigate unfunded liabilities associated with recent court cases.

ACTION: Amend Chapter 440, Fla. Stat., to address the cost implications of the *Westphal* and *Castellanos* decisions, and amend the attorney fee statute.



Payment In Lieu of Taxes (PILT) Program

NEED: Secure full funding of PILT funds to local governments for lost property tax revenues from federal lands.

ACTION: Mobilize elected officials to encourage Congress to fully fund the PILT program.



Bicycle and Pedestrian Safety

NEED: Enhance bicycle and pedestrian safety in SW Florida. **ACTION:** Endorse legislative and policy efforts that improve bicycle and pedestrian safety.

Funding Requests (State Appropriations)



Goodland Dr. Rehabilitation

NEED: Elevate Goodland Dr. to make it passable. (CR 92A). **ACTION:** Request \$2.0 million in State funds for preliminary engineering and design work.

FUND: Fixed Capital Outlay - EDT Projects - Road Fund



Replacement or Rehabilitation of 11 Bridges in Eastern Collier

NEED: Replace or rehabilitate eleven (11) bridges in eastern Collier County.

ACTION: Request \$500,000 for construction.

FUND: Fixed Capital Outlay - EDT Projects - Road Fund



Golden Gate City Outfall System Replacement Program (Phase I)

NEED: Improve the Golden Gate City storm water system.

ACTION: Request \$950,000 for Phase I construction. (There is a commitment of \$950,000 in local matching funds.)

FUND: Grants and Aids to Local Governments and Nonstate Entities - Fixed Capital Outlay Grants and Aids - Water Projects



Bayshore Gateway Triangle CRA Waterline Upgrades and Fire Suppression Improvements

NEED: Upgrade inadequate waterlines in the Bayshore Gateway Triangle CRA to improve fire suppression capabilities.

ACTION: Request \$750,000 for Phase II of project. (Phase I was jointly funded by the City of Naples and the County. For Phase II, the County will match any State appropriation.)

FUND: Grants and Aids to Local Governments and Nonstate Entities - Fixed Capital Outlay Grants and Aids - Water Projects



Pedestrian Bridge Connecting Gordon River Greenway Park with Freedom Park

NEED: Connect Gordon River Greenway Park with Freedom Park.

ACTION: Request \$500,000 for design work.

FUND: Fixed Capital Outlay - EDT Projects - Road Fund
