EXECUTIVE SUMMARY

Recommend Approval of Work Orders HM-FT-3902-06-05 and HM-FT-3902-06-06 under contract NO. 06-3902 with Humiston & Moore Engineers for permitting, surveying and construction observations of Wiggins Pass Maintenance & Dredging Project No. 900012 for a not-to-exceed, lump sum/time and material price of \$67,665.00

OBJECTIVE: Recommend approval of Work Orders HM-FT-3902-05 and HM-FT-3902-06-06 to Humiston & Moore Engineers for permitting, surveying and construction observations of Wiggins Pass Maintenance & Dredging Project No. 900012 for a not-to exceed, lump sum/time and material price of \$67,665.00.

CONSIDERATIONS: Development of the engineering required to secure a Notice to Proceed for the Wiggins Pass maintenance dredging. This includes pre and post construction surveys and engineering to support a disposal location from R-22 to R-25. This activity is defined under Work Order HM-FT-3902-06-05 and will cost \$30,770.00.

H&M will be assisting the County with construction observations during construction of the beach restoration project. Their proposal is based on an estimated construction period of 45 days. This activity is defined under Work Order HM-FT-3902-06-06 and is projected to cost \$36,895.00.


<u>COUNTY ATTORNEY FINDING</u>: A finding by the County Attorney is not required for this item.

As requested, we are providing this proposal for assisting the County with obtaining the Department of Environmental Protection (DEP) Notice to Proceed under the existing permit for the referenced project. This proposal includes requesting a modification to the permit to allow placement of the dredged material on the beach between DEP reference monument R-22 extending southward toward R-25, with the actual shoreline distance to be determined based on the quantity of material and the design template for Vanderbilt Beach. The required drawings needed to submit the request for modifying the disposal plans will be prepared based on the use of recent survey data collected for Collier County by Coastal Planning and Engineering. The scope of work includes responding to questions from regulatory agencies, however, it does not include additional studies or data collection if such are required to obtain regulatory approvals. Project construction plans will be prepared from permit drawings approved under the Notice.

Additional surveys needed for the maintenance dredging are included in this proposed scope of work. It is assumed that surveys recently completed for the Wiggins Pass Monitoring Report and the County's Beach Monitoring Surveys will be sufficient for permitting purposes. It is further assumed that a preconstruction survey of the beach will not be required. This scope of work is therefore limited to a preconstruction survey of the channel, plus a postconstruction survey of the channel and the beach. The scope of the beach surveys will be a modification of the previous survey scope approved under the existing permit, which includes 13 beach profiles from R-10 to R-22, inclusive. The modified scope will be 13 profiles from R-13 to R-25, inclusive.

Scope of Work and Budget

1. <u>Permitting.</u> Prepare and submit a request for Notice to Proceed under the existing permit, including a request to modify the location of the beach disposal location, and prepare construction plans. <u>(Time and Materials Billing)</u>

As requested, we are providing this proposal for assisting the County with Construction Observations during construction of the referenced beach restoration project. This proposal is based on an estimated construction period of 45 days. It is our understanding that H&M's responsibilities will include attendance at a preconstruction meeting, attendance at weekly construction progress meetings, review of contractor payment requests and making recommendations to the County regarding progress payments, daily construction site observations, consulting with County staff and the contractor regarding requirements of the construction specifications and regulatory permit requirements including a DEP approved QA/QC plan, and receiving and review of contractor daily reports of operation. This scope of work also includes processing of preconstruction and postconstruction survey data to determine the quantity of material to be dredged, documenting the quantity actually dredged, documenting the postconstruction conditions of the beach fill area and preparing a post construction report to satisfy regulatory permit conditions. (The preconstruction and postconstruction survey data collection task was submitted as part of a separate proposal)
