I could not find the July 14, 2008 ORC Report to the County from the DCA entitled "Objections, Recommendations and Comments Report" in the RLSA library or the RLSA Restudy library. Among other things, this report expressed DCA's strong feeling the Big Cypress area of Critical State Concern would suffer adversely from multiple impacts and thereby violate the Florida Administrative Code. This report is referred to in the 4/7/09 Executive Summary by County Staff to the BCC.

The Report may pertain to the DCA review of the 2006 cycle of GMP amendments approved for transmittal April 2008, as the RLSA revisions would be a large amendment to the GMP. This document is important to put in the library for the RLSA restudy.

Also, in the transcript of the hearing before the BCC 4/2009 on the 5 year review recommendations, the 1000 Friends of Florida speaker discussed a 6/16/08 letter from the DCA to the County that expresses the DCA's position that credits should be capped at 315,000. I also could not find this letter in either of the RLSA libraries. Will you add this document to the library?
