**TEMPORARY USE EXTENSION MODEL HOME/MODEL SALES CENTER**

LDC sections 5.04.01, 5.04.04 & 10.02.06 F.

Chapter 4 J.5 of the Administrative Code

Section 5.04.04 of the Collier County Land Development Code states that extension of a temporary use permit for a model home or model sales center in base zoning districts, except for properties in the Golden Gate Estates Subdivision, may be granted for a maximum of three years and requires public notice and a public hearing before the Planning Commission. Any additional extension beyond this three-year period would require a conditional use permit in accordance with LDC Section 10.08.00.

The terms and period of extension for model homes and sales centers in Planned Unit Developments and in the Golden Gate Estates Subdivision will vary. Please confirm the terms of extension with the Business Center at 239-252-2400.
