

FINAL PUBLIC NOTICE

The Federal Emergency Management Agency (FEMA) has received the subgrant application for Collier County repairs to Vineyards Community Park due to damages in Hurricane Irma (DR-4337-FL PW-05447). Pursuant to Executive Order 11988 and 44 CFR Part 9.12, final notice is hereby given of FEMA's intent to provide funding for projects under the Public Assistance (PA) Program.

An initial disaster-wide Public Notice was published October 6, 2017 for Hurricane Irma. Comments and other information received were fully evaluated by FEMA along with evaluation of social, economic, environmental, and safety considerations. This notice serves as a project-specific final notice for FEMA's funding action located within the floodplain.

Funding for the proposed project will be conditional upon compliance with all applicable federal, tribal, state and local laws, regulations, floodplain standards, permit requirements and conditions. This action complies with the National Flood Insurance Program (NFIP) requirements.

- Floodplain:** Project locations are located in the AH Zone, otherwise 100-year floodplain, per the Collier County FIRM map #12021C0401H, dated 05/16/2012.
- Proposed Work and Purpose:** Collier County will utilize force account and contracts to make repairs to fencing, lighting elements, soccer goals, wall paint, roofing components, drywall, ceiling tiles, wind screen, mesh roofing, shade structure, bleachers, signage, irrigation system, sidewalk, and ice machine at Vineyards Community Park. Tie-down anchors will be installed on the bleachers to help prevent future damages. Structural damages are located above the base flood elevation.
- Project Alternatives:** The alternative that has been considered is the no action alternative. Alternate locations were not considered as relocating the facility outside of the floodplain is not feasible. Parks facilitate open space and recreational usage of floodplains. The Vineyards Community Park supports the Naples community by providing recreational and open space facility and relocation may adversely impact social or economic resources for the community.
