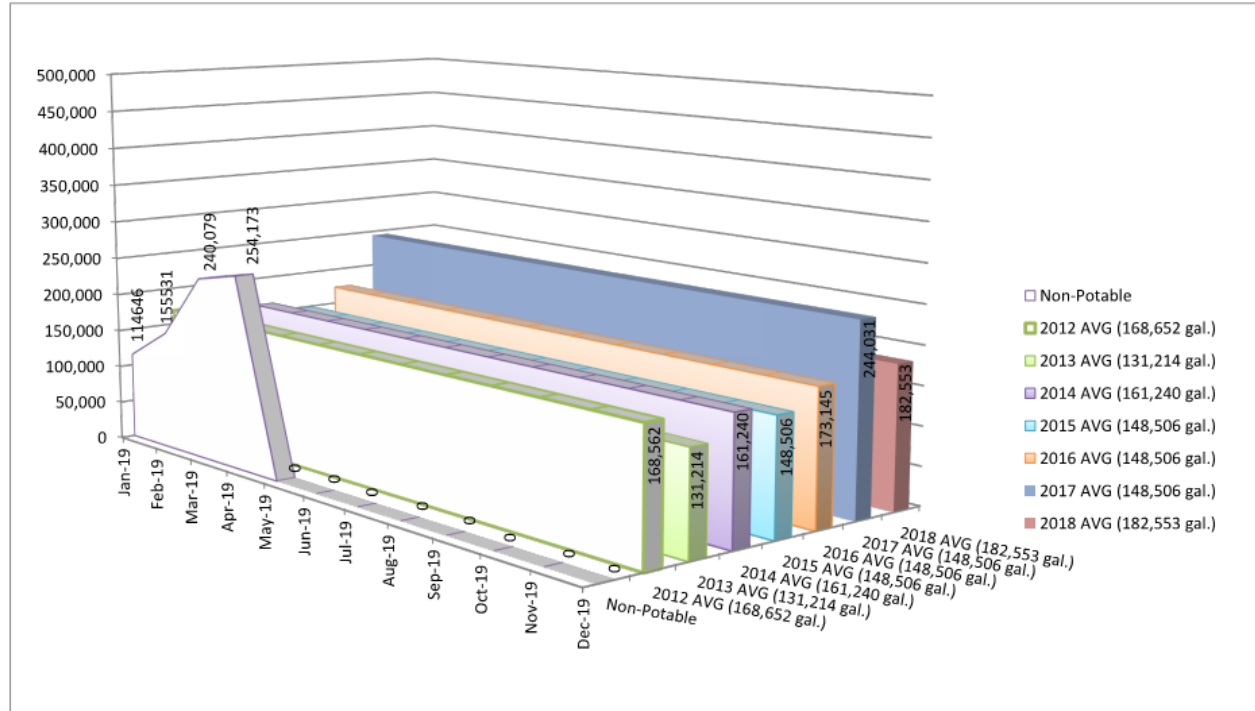

Water Use Goal: (1.47 ac. of Plants & Turf)

Recommended: Supplemental watering rate of .75 to 1 inch per week. One inch per week equals 39,917 gallons per week or 159,668 gallons per month.

- 2013 total water use: 1,574,562 gallons or 39.45 inches of supplemental water pumped
