AN ORDINANCE AMENDING ORDINANCE 82-2,  
THE COMPREHENSIVE ZONING REGULATIONS  
FOR THE UNINCORPORATED AREA OF COLLIER  
COUNTY, FLORIDA BY PLACING THE "MH" MOBILE HOME  
OVERLAY ON ALL "A-1" AND "A-2" ZONED  
LANDS LOCATED WITHIN THE EXISTING IMMOKALEE  
AREA PLANNING DISTRICT AND LOCATED WITHIN  
THE IMMOKALEE AREA PLANNING DISTRICT WHICH  
EXISTED PRIOR TO MAY 1, 1979, AND LANDS  
LOCATED IN THE N $\frac{1}{2}$  OF SECTION 25, TOWNSHIP  
49S, RANGE 27 E AND IN THE S $\frac{1}{2}$  OF S $\frac{1}{2}$  OF SEC-  
TION 24, TOWNSHIP 49S, RANGE 27E; AND BY  
PROVIDING AN EFFECTIVE DATE.

Whereas, the Community Development Division has peti-  
tioned the Board of County Commissioners to place the "MH"  
Mobile Home Overlay on the real property herein described;

NOW, THEREFORE BE IT ORDAINED by the Board of County  
Commissioners of Collier County, Florida:

Section One:

The Zoning Classification of the herein described real  
property is changed from "A-1" and "A-2" to "A-1MH" and "A-2MH"  
and the Official Zoning Atlas Maps as described in Ordinance  
82-2 are hereby amended accordingly:

All "A-1" and "A-2" lands located within the following  
Townships and Ranges:

Township 46 South, Ranges 28 through 30 East; and  
Townships 47 & 48 South, Ranges 27 through 30 East;  
and Township 49 South, Ranges 28 through 34 East;  
and the S $\frac{1}{2}$  of the S $\frac{1}{2}$  of Section 24, Township 49 S,  
Range 27E and the N $\frac{1}{2}$  of Section 25, Township 49 South,  
Range 27 East.

Section Two:

This Ordinance shall become effective upon notification  
that it has been recorded by the office of the Secretary of  
State.

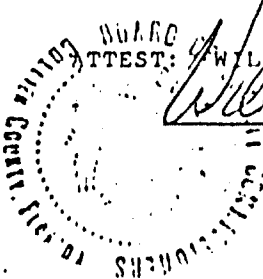
