All "A-1" and "A-2" lands located within the following Townships and Ranges:

Township 46 South, Ranges 28 through 30 East; and Townships 47 & 48 South, Ranges 27 through 30 East; and Township 49 South, Ranges 28 through 34 East; and the S½ of the S½ of Section 24, Township 49 S, Range 27E and the N½ of Section 25, Township 49 South, Range 27 East.
