AN ORDINANCE AMENDING ORDINANCE 82-2, THE COMPREHENSIVE ZONING REGULATIONS FOR THE UNINCORPORATED AREA OF COLLIER COUNTY, BY ADDING SECTION 9.12, TO PROVIDE THAT ANY ENTITY WHICH WISHES TO DONATE PROPERTY TO THE COUNTY FOR PUBLIC USE MAY PLACE THE NAME OF THE ENTITY DONATING SAID PROPERTY ON THE DONATED PROPERTY, UPON REVIEW BY THE PLANNING AND ZONING DIRECTOR AND APPROVAL BY THE BOARD OF COUNTY COMMISSIONERS; AND BY PROVIDING FOR AN EFFECTIVE DATE.

WHEREAS, it has come to the attention of County Staff that certain entities are willing to donate property for use by the public, such as trash cans, recreation equipment, benches, etc.; and

WHEREAS, these items would be in the best interest of the public welfare; and

WHEREAS, an entity that donates such items, on occasion, desires to have their name printed on said items to identify the donor; and

WHEREAS, Section 8.31 of Ordinance Number 82-2, the Comprehensive Zoning Regulations for the Unincorporated Area of Collier County, considers such identification as a sign and regulates the size and placement of said sign; and

WHEREAS, in particular circumstances, such identification would be prohibited by Section 8.31; and

WHEREAS, the County Staff recognizes the propriety of such identification when done in a manner consistent with those requirements set forth below;

NOW, THEREFORE BE IT ORDAINED BY THE BOARD OF COUNTY COMMISSIONERS OF COLLIER COUNTY, FLORIDA:

SECTION ONE:

Collier County Ordinance No. 82-2, Section 9 Special Regulation shall be amended to add Subsection 9.12, which shall read as follows:

9.12 Special Regulations for Property Donated for Public Use.

Any entity may request to donate property to Collier County in accordance with those provisions set forth below. The acceptance of such property shall be at the sole discretion of the Board of County Commissioners. The Board of County Commissioners, in its review for acceptance of such property, shall consider the type of property including its design,

color and size, the placement of said property and other pertinent characteristics of the property. Upon acceptance of the property by the Board of County Commissioners, the entity shall be permitted to place its name on the donated property in the following form: "Donated by (name of donor)". The design, size and placement of the donor name on the donated item shall be reviewed by the Board of County Commissioners to assure compliance with the following criteria:

- (a) The lettering shall be no larger than two (2) inches and shall contain no information other than that set forth above; and
- (b) The lettering shall be white, black or other unobtrusive colors appropriate to the color of the donated item; and
- (c) The design and placement of the lettering shall be appropriate to provide identification of the donor, if such identification is requested.

The Board of County Commissioners shall thereafter approve, approve with changes or deny the design.

The name of the donor on donated property for public use, in accordance with the criteria set forth above, shall not be considered a sign.

SECTION TWO:

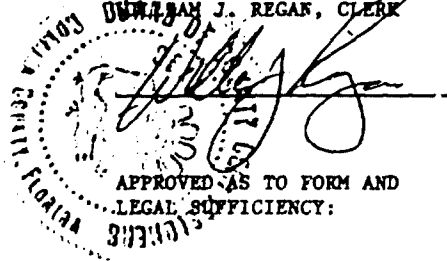
This Ordinance shall be come effective upon receipt of notice that it has been filed with the Secretary of State.
