NOW, THEREFORE BE IT ORDAINED by the Board of County Commissioners of Collier County, Florida:

SECTION ONE:

Collier County Ordinance 82-2, Section 7.23, C-4 Commercial General, Subsection 7.23 b.3) Permitted Provisional Uses and Structures shall be amended as follows:

- (a) Car wash.
 - (b) Child Care Center.
 - Commercial recreation outdoor
 - (d) Detached residence in conjunction with a business - one (1) per business.
 - (e) Drive-in theatres.
 - (f) Permitted use with less than 1,000 square feet gross floor area in the principal structure.
 - (g) Used car lots and outdoor boat sales.
 - (h) Vehicle Rentals all vehicles except automobiles
 - (i) Hotels and motels.
 - (j) Time share facilities.
 - (k) Retail sales of propane gas.
 - (1) Television stations (offices and studios) and auxiliary transmitters and receiving equipment, but not principal transmission tower.
