AN ORDINANCE AMENDING ORDINANCE 82-2, THE COMPREHENSIVE ZONING REGULATIONS FOR THE UNINCORPORATED AREA OF COLLIER COUNTY BY AMENDING SECTION 7.23 COMMERCIAL GENERAL, SUBSECTION 7.23.b.1 PERMITTED PRINCIPAL USES AND STRUCTURES TO PERMIT EQUIPMENT REPAIRS AND SALES WHEN ASSOCIATED WITH EQUIPMENT RENTALS; AND BY PROVIDING AN EFFECTIVE DATE.

WHEREAS, equipment rentals including lawn mowers and power saws are a permitted principal use in the C-4 district; and

WHEREAS, the repair and sale of the rental equipment is a typical part of such a business;

NOW, THEREFORE BE IT ORDAINED by the Board of County Commissioners of Collier County, Florida:

SECTION ONE:

Collier County Ordinance 82-2, Section 7.23, C-4 Commercial General, Subsection 7.23.b.1) Permitted Principal Uses and Structures) shall be amended as follows:

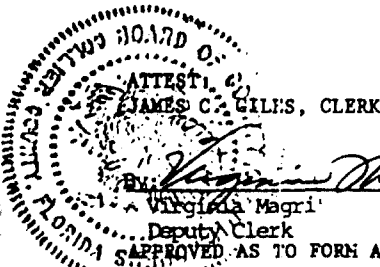
- (e) Electrical supply stores; equipment rentals, including lawn mowers and power saws, which may include their repair and sale.
