JAMES AN ORDINANCE AMENDING ORDINANCE 82-2, THE CLERK OF COMPREHENSIVE ZONING REGULATIONS FOR THE COLLIER COUNTY UNINCORPORATED AREA OF COLLIER COUNTY BY AMENDING SECTION 7.22, C-3 COMMERCIAL INTERMEDIATE, SUBSECTION 7.22 b.1) (1); TO ADD MUSEUMS AS A PERMITTED PRINCIPAL USE AND BY PROVIDING AN EFFECTIVE DATE.

WHEREAS, museums are a permitted principal use in the C-3, C-4 and C-5 districts; and

WHEREAS, museums are similar in intensity to permitted principal uses in the C-3 zoning district;

NOW, THEREFORE BE IT ORDAINED by the Board of County Commissioners of Collier County, Florida:

SECTION ONE:

Collier County Ordinance 82-2, Section 7.22, C-3 Commercial Intermediate, Subsection 7.22.b.1) (1) Permitted Principal Uses and Structures shall be amended as follows:

- (1) meat market; medical office or clinic for human care; millinery shops; museums; music stores

SECTION TWO:

This Ordinance shall become effective upon notice that it has been received by the Office of the Secretary of State.


