



## COLLIER COUNTY RABIES/LICENSE TAG APPLICATION

Collier County Animal Control Ordinance required that the owner of any dog(s) and/or cat(s) over four months of age obtain a Collier County Rabies/License Tag and a current rabies vaccination, administered by a licensed veterinarian. Proof of current rabies vaccination is required to purchase a County Rabies/License Tag. **Tags are valid for a period of one (1) or three (3) years from the date of vaccination**, depending on the expiration date of the rabies vaccination the animal receives, and is required to be renewed annually or tri-annually thereafter, and must remain current at all times. **No County Rabies/License Tag shall be valid after the expiration of the Rabies Vaccination, regardless of the date of issuance.**

- **A copy of your pet's Rabies Certificate** – Proof of a current Rabies Vaccination, or a waiver from your Veterinarian, is required to purchase a tag.
- **Proof of Spay/Neuter** - Proof of spay or neuter is required for the discounted tag. Proof is only required one time; Spay/Neuter gender on your pet's Rabies Certificate is sufficient proof.

You may also purchase your pet's license via mail; please mail all license requests to our Davis Blvd office (Do NOT send cash by mail).

**\*\*The license you purchase WILL NOT exceed the expiration date of your pet's current Rabies Vaccination\*\***

If your sterilized pet ever gets lost and is brought to DAS, and has a current county rabies/license tag, impound and board fees may be waived for cats and dogs reclaimed before the end of the standard holding period, during their first impoundment.

In the event of a disaster, your pet's current license replaces the need to pre-register for the Pet Friendly Shelter. Admission to the shelter is on a first-come, first serve basis for Collier County residents; only cats and dogs are accepted at this time.
