Developing both a senior and affordable housing website to make locating services easier for everyone. Evaluating our survey data to make us better and provide better service to our neighbors.

Now Accepting Electronic Payment!



To continuously strive to provide more convenient options to our clients, CHS is proud to offer electronic payment! CHS accepts electronic payment in the form of credit, debit, mobile payment and e-check. The addition of e-check enables a payment to be directly drawn from a client's bank account, eliminating the hassle of writing a check and mailing it in. E-check can be particularly convenient for caregivers taking care of financial obligations for their family members receiving services from CHS. Also, clients who come into our office no longer need to make sure they have exact change before their visit. By accepting electronic payments, deposit processing time is reduced.

Staying Healthy in 2020

Last year, CHS helped over 480 adults with medical assistance for life threatening issues and conditions who otherwise could not afford private insurance and do not qualify for Medicaid. Assistance is available for testing, x-rays, day surgery and treatment. Prescription assistance is also provided to eligible patients who have physician prescription orders. In 2019, 114 clients received prescription assistance. Pharmacies are located in Naples and Immokalee to allow ease of access to our customers.

To qualify for our medical or prescription program, one of our case managers will review eligibility and medical necessity. Once a person is determined eligible for referral services, a co-payment of \$10 is assessed for each medical procedure and \$5 for each prescription.

Eligibility criteria:

- Adult 19-64 years of age
- Proof of Collier County residency
- Proof of legal status
- No other medical insurance
- Medicaid denial paperwork
- Must meet 150% of the Federal Poverty Guidelines

Case managers are available 5 days per week at the Community and Human Services office located in Building H of the Government Complex and two days per week in Immokalee.

Mo' Money

The Collier County Community and Human Services Division opened the FY 2020-2021 grant application cycle, at midnight on January 3, 2020. During the FY 2020-2021, Collier County is scheduled to receive federal funds from the U.S. Department of Housing and Urban Development (HUD) Community Development Block Grant (CDBG) funds, HOME Investment Partnership Program (HOME) funds and Emergency Solutions Grant (ESG) funds. In addition, Collier County will receive an annual allocation of State Housing Initiative Partnership (SHIP) funds. Local funds from the Housing Trust Fund will also be made available.

The application submission period for local, State and Federal grant funds closes on Monday, February 10, 2020. All applications must be consistent with Collier County's Consolidated Plan and/or SHIP Local Housing Assistance Plan (LHAP).

The U.S. Department of Housing and Urban Development (HUD) supports projects that meet one or more of the three national objectives:

- Benefits low and moderate-income persons or households who earn at or below 80% of the median income
- Aids in the prevention or elimination of slums or blight
- Qualifies as a certified urgent need

SHIP strategies that may be funded include:

- Purchase Assistance
- Housing Rehabilitation
- Demolition and Replacement

Federal CDBG, HOME and ESG funding totaling approximately \$3,000,000 may be available. State SHIP funds are estimated to be approximately \$700,000. Funding amounts are subject to change based on actual amounts awarded from grantor agencies and availability of funds. All applicants are required to participate in a one-on-one technical assistance meeting in order to submit an application. No applications will be accepted unless a one-on-one technical assistance meeting has occurred. CHS staff will review all applications received to assure they meet all fatal requirements. Those that qualify will be given to the Review and Ranking Committee, which will be appointed by the County Manager, to critique and score the applications. Based on application presentations and total scores the Review and Ranking Committee will make funding award recommendations to the Board of County Commissioners at the June 23rd BCC meeting.

Community Land Trust Takes Shape

On October 22, 2019 the Board of County Commissioners approved moving forward with the Collier County Land Trust, another step closer toward achieving our goals outlined in the County's Housing Plan. Housing Development Corporation of SW Florida, Inc. d/b/a H.E.L.P. filed the articles of incorporation for the new entity named the "Collier County Community Land Trust" (CCCLT) on October 24, 2019.

On December 11, 2019, the CCLT held its first Board recruitment training webinar in collaboration with the Florida Housing Coalition.

There were 6 potential board members who participated in the training. The proposed initial members include: Steven Hruby, David Ellis, Mary Jo Diegel, Todd Sabin, Jenna Buzzacco-Foerster, and Mike Prioletti. The group has a diverse background including commercial development, commercial real estate, law, government relations and wealth management.

The initial Board of Directors meeting has been set for January 2020. Preliminary By-Laws have been drafted in collaboration with Legal Aid Services and the Florida Housing Coalition and the initial board meeting will review and discuss these proposed by-laws. The CCLT is on its way to effecting great change in the area of affordable and attainable housing.

Subrecipient Corner- Collier County Housing Authority

The Collier County Housing Authority (CCHA) was created in 1966 by the State Legislature with the sole purpose of providing housing for low-income families, including the elderly and persons with disabilities. CCHA is governed by a five-member Board of Commissioners appointed by the Governor, and currently owns and manages four public housing developments consisting of 813 units. The units are in Immokalee's Farm Worker Village, a low-income housing development, a farm labor housing development and Horizon Village which is a dormitory facility. CCHA also administers the HUD, HOME, TBRA Section 8 Family Self Sufficiency Programs to low, elderly, disabled and homeless persons, serving approximately 3,100 persons that live in Collier County.

Subrecipient Corner, Cont'd



The Tenant Based Rental Assistance Program (TBRA) is a rental subsidy that may be used to help individual households afford housing costs by paying all, or a portion of a families rent and security deposits. It may also assist tenants with utility deposits. The Collier County Housing Authority re-established their commitment to the TBRA program by applying for, and being awarded, HOME funds in 2017 which will carry them through 2021.

Angela Edison, Director of Housing says "Our mission is to provide choices for families to have decent, safe and affordable housing with opportunities for education and guidance in achieving economic upward mobility. We are super grateful for the partnership with CHS, for the commitment

and dedication to our community to make life changing improvements to the quality of life for the residents we serve."
