



The Collier County Preliminary Flood Insurance Rate Maps (FIRM) focus on areas that can be affected by coastal flooding. FEMA has utilized new and improved topographic mapping technology to assess the coastal flood risk.

On March 2 and 3, 2020 Collier County, along with the City of Naples, City of Marco Island, and FEMA staff, hosted open houses to provide information regarding preliminary changes to the FIRM. Property owners and residents were able to discuss with FEMA staff, changes to insurance requirements associated with the map update. The maps are preliminary and have not been adopted by Collier County.

Collier County has been a participating community in the National Flood Insurance Program since Sept. 14, 1979; when the first FIRM was adopted. Here are some interesting facts about Collier County's Floodplain Management Program:

• The FIRMs identify different Special Flood Hazard Areas (SFHA). Collier County SFHA flood zones are A, AE, AH, and VE. Flood zones are designated based on different characteristics, such as flood depths, flooding source, etc.

As we approach spring a/k/a "fire season", we would like to take a moment and go over a few preventive steps to preparing your property especially if you reside in the Golden Gate Estates area.

Clearing vegetation within 30 feet of a structure is the recommended defensible wildfire space. This is usually done when the home site is initially cleared, upon construction permit approval. Single-family homeowners within Golden Gate Estates can clear up to one acre after the Building Permit for a single-family home is issued.

Existing residences which have not cleared up to one acre, may clear up to a maximum of one acre at any time. If one acre of vegetation has already been removed and an additional clearing within 30 feet of structures is proposed, then a Vegetation Removal Permit is needed. The allowed clearing is the same whether a lot is one acre or five acres in size. Please note that there are stricter clearing allowances for properties located in the Rural Fringe Mixed Use District, within Special Treatment Overlays, and inside Areas of Critical State Concern.

These simple steps can significantly reduce the risk of fire to your home:

- Clean leaves and pine needles from your roof, gutters, eaves, and porches;
- Remove tall grasses and vines from around trees and shrubs;
- Replace vegetation under porches or decks with gravel;



Residents and visitors at Marco Island are now able to enjoy a wider, more robust since the completion of the Caxambas Pass beach resourishment project. Approximately 80,000 cubic yards of sand was used to refurbish South Beach.

The Board of County Commissioners awarded the contract for the project, funded by Tourist Development, to contractors in late 2019. Once underway, crews worked around the clock to reach completion before sea turtle nesting season, as required by the Department of Environmental Protection permit.

# **GIVE THE DOG A BONE HAND!**

Pets are a "waggingly" wonderful addition to our lives. As part of our families, they deserve what's best. So, give your dog a hand, because they sure don't have one.

An absolute necessity for both our health and the health of our dogs is the proper disposal of pet waste, or what we like to call "poo-lution."

Now, let's talk some basics. There are more than 15,000 registered dogs in Collier County. It is estimated that 40 percent of dog owners leave pet waste on the ground. That means almost two tons of poo-lution are being left on the ground each day in Collier County. Phew, talk about a big pile of you-know-what!

Poo-lution is a source of both nutrients and bacteria. When it rains, any poo-lution left on the ground gets washed into our local water. With a significantly higher concentration of phosphorous than waste from cows and other domesticated animals, dog waste provides the nutrient that is most likely to start an algae bloom or cause a fish kill. It is also recognized as the third highest source of bacterial pollution in our nation's waterways. Excess

bacteria in our local waterways is not healthy for the wildlife and makes the water unsuitable for activities such as swimming.

Be part of the "Poo-lution Solution." Simply add "scoop the poop" to your once a week chore list, or hire a pooper-scooper, to keep your backyard clean and safe for your pet.

Don't have a backyard? Enjoy taking your dog out on the town? Love the dog park? Tie a couple bags to your dog's leash so that you're always prepared to pick up after your dog. # MEDICAL SUPPLIES & COVID-19 ASSISTANCE BY CODE ENFORCEMENT


# **Easily Report Non-Emergency Issues within the County**

# **TIMING SIGNALS IS A SCIENCE**

Did you ever wonder how we keep you moving along Collier County's main roads without having to stop for too many red traffic signals along the way? How is it possible that even in peak rush hour, you can go for miles without having to stop at an intersection? Here is a look at the process and technology our Traffic Operations team is deploying to ensure that travel times are short and intersections function effectively, while keeping us all safe on the road:

The device that contains the timing for a traffic signal is called a traffic controller. The traffic controller is an advanced computer that has been specifically designed to control a signalized intersection. The timing of signalized intersections in Florida is required to meet federal, Florida Highway Administration (FHWA), and state, Florida Department of Transportation (FDOT), standards. Coordination of intersections allows us to synchronize multiple intersections to enhance the traffic flow. This provides progression on major roads (i.e. arterials) with minimum delay.


So how do we come up with those timing plans to coordinate multiple intersections? First, we have to do some counts...

Traffic Volume Counts - Every three months we count all the vehicles that pass at specific locations. continued on page 10

# **REPORT A TRAFFIC SIGNAL ISSUE**

Collier County provides several methods of reporting traffic signal issues, and we want to know if a problem occurs. Turning Movement Counts - The turning movement counts will determine the green time allocation for each direction at an intersection. ...and then we come up with a plan.

**Timing Plan Development -** The basic timing, intersection geometrics, and turning movement volume counts are coded into a computer software program that develops the optimal coordinated timing for each intersection on the arterial.

**Timing Plan Implementation and Fine-Tuning -** The timing plans (patterns) are transferred from the computer software to each traffic controller on the arterial. Then we do some test drives and any timing adjustments that are needed to minimize delay. When we need to coordinate several signals, the last step is to perform a delay study. The arterial pattern is determined with a laptop and software that evaluates arterial progression and delay. This study is performed in each direction, three times for each pattern, for a total of 72 runs.

Three types of coordination systems are currently in operation in Collier County. They are 'pre-timed', 'traffic response', and 'traffic adaptive'.

- Pre-timed coordinated systems implement predefined patterns according to a time of day events or seasonal demand.



# **BUSINESS AS USUAL DURING COVID-19**

The Road Maintenance Division hasn't skipped a beat during the current COVID-19 pandemic. Staff has continued delivering on customer expectations by providing timely scheduled maintenance and customer service.

According to Road Maintenance Division Director Albert English, "We are confident that the Division will continue to perform everyday operations with business as usual. Road Maintenance staff members are considered essential employees and take their commitment to the public very seriously." Road maintenance, landscaping, and bridge and sidewalk repair schedules have remained on schedule.

The Division readies itself throughout the year to be prepared for the unexpected. In response to the pandemic, modifications have been made to hours and work schedules for staff, with a small percentage working remotely from home fielding phone calls and providing customer service and technical support.

# LANDSCAPE AND IRRIGATION

The landscaping and irrigation team has been very busy during these challenging times. Even though we have been short-staffed at times due to the pandemic, we've accomplished many feats. We are trimming all the trees and palms within the 120+ mile Landscape Beautification Master Plan (LBMP) area. We are continuing to fertilize all medians and mulching most; removing 11

dead vegetation; and systematically replanting 100 miles of medians damaged by Hurricane Irma (20 miles in the LBMP are new medians not in need of replanting). We also made multiple irrigation repairs during the epic drought.

Additionally, we are working as a team with Transportation Engineering on their turn lane projects, transplanting material from the new footprint into our existing medians elsewhere. We are preparing to construct later this year a Federal Department of Transportation (FDOT) grant project on North Tamiami Trail in the Pelican Bay area. This constitutes landscape replacement and irrigation upgrades. Simultaneously, we are managing our existing landscape maintenance through our four contractors. Our own crews continue to stay busy with repairs, accident clean-up, and minor projects. Professional staff continues to work diligently managing all of the above projects and designs along with project managing the replacement plans, reviewing Right-of-Way (ROW) permits, and coordinating landscape maintenance agreements (LMA's).



The Collier County Growth Management Department Floodplain Management Section is part of the Building Plan Review & Inspection Division and is staffed by seven team members. Staff reviews construction plans for FEMA regulations compliance, advises and assists design professionals on the technical aspects of flood-resistant development, guides residents and insurance agents on the interpretation of the FIRMs and Elevation Certificates and annually provides floodplain management outreach to various professional and civic organizations.

- Replace mulch with hardscape gravel or stone;
- Remove all flammable items within 30-feet of structures, including dry and dead vegetation and grass clippings, propane tanks, and items stored on decks; and
- Prune branches on trees six-to-10 feet from the ground.

A permit is not required for clearing for fire breaks built by the Florida Forest Service (FFS) which are approved by FFS as part of a wildfire mitigation plan. For single family lots within the Golden Gate Estates, clearing for fire breaks is allowed in addition to the one acre allowed for the home site as long as these fire breaks are or were created by the FFS or reviewed and approved by FFS as part of a wildfire mitigation plan. This includes roller-chopping and other fuel reduction methods.

We hope you find this information helpful during and while preparing for fire season each year. Additional references available are listed below.





the most responsive to actual traffic demand and seasonal demand. Collier County currently has this type of system on Airport Road South and is in the process of installing the same type of system on the western part of Immokalee Road.

### Did COVID-19 have an impact on our signal timing plans?

Yes, due to reduced traffic volumes on Collier County roadways, staff has adjusted the coordination timing to reduce delay while it is safer for all of us to stay at home.
