

PURPOSE

This guide provides step-by-step instructions on how to apply for and change a Short-Term Vacation Rental Registration Certificate using the GMD Public Portal.

GENERAL INFORMATION

- Property Owners and Applicants are required to have a confirmed Registered GMD Public Portal User account.
- Only one address/unit is allowed per Short-Term Vacation Rental (STVR) Registration Application, individually uploaded, for each property address.
- Vacation Rental is defined as any habitable space, including a room, apartment, or living quarters, in any residential building, including but not limited to condominiums, single-family or multi-family homes.
- Short-Term Vacation Rental is defined as any unit, group of units, dwelling, building, or group of buildings within a single complex of buildings that are rented to guests more than three times in a calendar year for periods of less than 30 days or 1 calendar month, whichever is less, or which is advertised or held out to the public as a place regularly rented to guests.
- Applicant must provide a valid Florida Department of Business and Professional Regulation (DBPR) license. (Any Owner who is not required to register with the Florida Department of Business and Professional Regulation, as defined by F. S. Ch.509, is exempt from this Ordinance)
- The Short-Term Vacation Rental Registration Application must be completed, with all required signatures, before uploading to the GMD Public Portal.

- The Property Owner is required to submit to the County, using the Short-Term Vacation Rental Registration Application, any changes in property ownership or registered Designated Responsible Party within ten (10) business days of such change per the ordinance.
- A completed, updated Registration Application form identifying new Designated Responsible party information along with a completed Affidavit of Authorization form with all required signatures is required to be uploaded using the GMD Public Portal.
- Short-Term Vacation Rental Registration change of designated responsible party has a nonrefundable fee of \$ 50.00.

- 4. Click Permit Number: *Example: PL2022000439*, make sure the status says Issued.

- 6. Click the black arrow next to Documents & Images to expand.
- 7. Click on the current Letter Short-Term Vacation Rental Certificate to open and print.
