

PURPOSE

This is a guide to assist customers with applying for a garage sale permit on the GMD Public Portal. It also provides instructions on how to cancel a garage sale permit electronically.

GENERAL INFORMATION

- Must be a registered GMD Public Portal account.
- > GMD Public Portal Link: https://cvportal.colliercountyfl.gov/CityViewWeb/Home/
- For garage sale permit details refer to LDC 04-41 as amended, 5.06.06 Signs.
- The permit must be posted on the property where the garage sale is held.

PROCEDURE

A. Applying for A Garage Sale Permit

Make sure you are a registered user with our GMD Public Portal.

1. Sign In

- a. Click Sign In.
- b. Enter the email address and password.
- c. Click Login.





- 2. Under Special Events, Zoning Certificates, Temporary Use, and RV & Garage Sale Permits.
 - a. Click Apply for Permit.




- 3. Permit or Certificate Project Description.
 - a. Choose the project type.
 - Garage Sale Permit.
 - b. Project Descriptive Name and Project Description autoloads, enter additional comments about the project if necessary.
 - c. Name on Permit.
 - This name will show on the permit.
 - d. Enter Contact Phone number.
 - e. Click Next Step: Permit Type.

- 4. Permit or Certificate Permit Type Settings.
 - a. Click calendar to select **Start Date**.
 - b. Click the dropdown arrow, Select the **Number of Days?**
 - c. Click the dropdown arrow, Select Where is the Garage Sale?
 - Note: if you select Commercial, your application will be cancelled and you will receive a message providing instructions on how to apply.
 - d. Answer the question: I have not held a garage sale in the last six months.
 - Note: if you select False your application will be cancelled and you will receive an error message providing instructions on how to proceed.
 - e. Click Next Step: Location.



5. Permit or Certificate - Location of Project

- a. Search for address: Begin typing a street address or Parcel number, we will search existing locations within the jurisdiction. If your location appears, please select from the list. Select address from the list.
- b. Make sure your address loads in **The location you have selected** box.
- c. If your address does not populate in the list, you must **Click Can't find address** and manually enter the address.
- d. Click Next Step: Contacts.



6. Permit or Certificate - Review & Submit


a. **Review the information entered**, If changes are required, use the **Previous button** to go back and make the correction

- b. Scroll down to Acknowledgement, from dropdown arrow Select Agree,
 - Note: if you select **Disagree**, the system will not allow you to move forward.
- c. Type in the capture characters you see in the image in the box below it
- d. Click Submit Application



- a. Application Number is assigned
- b. Review the information, If changes are required, use the **Previous button** to go back and make the correction
- Scroll down to Documents and Images, Under Document Name, Click on the Garage
 Sale link and Print out Garage Sale Permit Application.

Conditions of Approval:

- Garage sale means a sale held anywhere on any residential premises for the purpose of disposing of
 miscellaneous personal articles (as furniture, tools, toys, clothing, etc.) typically found in a residential household or
 garage, by the resident of the premises where the sale is held.
- The sale of any animals is prohibited and it may constitute a land use violation. Please contact Domestic Animal Services at (239)252-PETS for Non-Commercial Breeder requirements.
- In a deed restricted community or which has community covenants, please check to see if your community has
 restrictions regarding garage sale permits. Any community restrictions with regard to garage sales will supersede
 the county ordinance in your community.
- The individual conducting the garage sale shall provide the control of parking for motor vehicles so as to reasonably prevent unsafe conditions and traffic congestion on the public street or streets adjacent to the premises upon which the sale is being conducted.
- A two-day permit may be issued for a garage sale, lawn sale and other similar temporary sales during each six-month period, and there shall be issued no more than 2 permits per premises per year (from the date of the last garage sale).
- This permit must be posted on the property where the garage sale is held.

Advertisement:

Collier County Sign Codes prohibit balloons, inflatables, streamers, pennants, and other wind signs, as well as
flashing lights or rotating displays. <u>Signs may not</u> be attached to any utility pole, traffic control sign, or anything in
the right of way. Collier County Land Development Code, Ordinance 04-41 as amended, 5.06.06 Prohibited Signs.

Any violation of these conditions or other applicable Collier County Ordinances will invalidate this permit and may result in other enforcement actions

B. Canceling a Garage Sale Permit

The following steps are only for those who submitted the application through the portal.

- 1. How to Cancel your application
 - a. Click Status and Fees.
 - b. Enter Permit number in the search box, click Go!
 - c. Click the Header Edit Special Events, Zoning Certificates, Temporary Use, Short-Term Vacation Rental registration, RV & Garage Sale Permit Application Details link.
 - d. Permit Cancellation: Click the drop-down arrow and select YES.
 - e. Click Update Application Details.
 - f. Application Status changes to Cancelled Closed for Uploads


